35		Mr. Deffobis started with a presentation on Shoreline Environment Designations as it
36		relates to Lake Lawrence parcel's proposed changes. He gave background information
37		on how citizens can verify what is proposed for their shorelines and whether or not the
38		proposed change is appropriate based on the scientific data. The criteria for assigning
39		SEDs were reviewed. There were questions and comments by the Planning Commission
40		which Mr. Deffobis answered. A discussion ensued.

42		<b>MOTION:</b> Commissioner DeHan moved to change the proposed shoreline
43		<u>environment designation for reaches LLA-5 – LLA-6 and LLA-6 – LLA-1 to</u>

1		<u>Shoreline Residential, and to move the southern boundary of Reach LLA-6 – LLA-1</u>
2		south to include the properties with residential development currently included in
3		<u> Reach LLA-1 – LLA-2. Commissioner Karman seconded. Motion carried with 5 yays</u>
4		and 1 nay.
5		
6		Next, the Planning Commission continued reviewing and discussing Chapter 19.500.
7		There were questions and comments from the Planning Commission as the review ensued
8		which Mr. Deffobis answered or noted on the draft document to get further clarifications.
9		Edits requested by the Planning Commission were also noted.
