

PROJECT BACKGROUND



PROJECT SCOPE

Update critical areas protections for 'New Agricultural Activities'

- Lands converted to agricultural use after July 24, 2012
- New agricultural facilities built after July 24, 2012 on existing or new ag land
- Expansion of agricultural facilities (outside existing footprint) on existing ag land



PROTECTING AND ENHANCING CRITICAL AREAS THROUGH CONSERVATION PLANNING


Department of Commerce's Critical Areas Handbook states:

"Conservation plans are intended to help agricultural operators maintain productive and economically viable agricultural land, while protecting and enhancing critical areas and water quality using best available science and effective mitigation measures. Conservation Plans can effectively reduce impacts from farm activities on natural resources with solutions unique to each farm to avoid or minimize adverse impacts with mitigation techniques."



CONSERVATION PLANNING APPROACH

- Reflects state guidance on CAO compliance
- Builds on VSP Program
- Balances goals for protecting working farmlands and critical areas
- Provides opportunities to incentivize beneficial conservation projects and climate-smart activities



JULY 20 CONCEPT REVIEW – CONSERVATION PLANNING APPROACH

Conservation Planning Process

- Prepared by technical service provider; reviewed and approved by county
- Identify benchmarks and mitigation measures for impacts--ensuring site-specific 'no net loss'
- Farmers participate in monitoring and adaptive mgmt. as prescribed in plan; county to enforce

- Goals
- Maps, Scope, and Timeline
- Implementation Plan
- Monitoring & Compliance

Repeal and replace Chapter 17.15 TCC, Agricultural Activities Critical Areas

- Details conservation planning option for new agricultural activities to comply with CAO
- New purpose statement, applicability, and general requirements sections
- Updated definitions
- New sections clarifying existing/ongoing versus new agriculture uses
- New provisions to remove barriers to conservation enhancement projects and climate mitigation activities
- Farm Conservation Plan standards, requirements, monitoring and compliance

Updating Title 24 Critical Areas Ordinance

- Default option for new agricultural activities to comply with CAO
- Updated references and definitions
- Revisions to use tables to include new agricultural activities and facilities
