Thurston 2045: the County's Periodic Update

- ► Required to periodically (ten-year cycle) update the comprehensive plan and development regulations
- ▶ Plans for the next 20 years to 2045
- ► Ensures consistency with the Washington State Growth Management Act
- ▶ Not a full repeal and replace, or a full re-visioning
- ▶ Next periodic update due June 30, 2025



Written Public Comment

- ▶ 84 public comments received to date
- Most comments are on specific changes to plan
- Major Themes:
 - ► Include Planning Commission in decision-making process for scope of work
 - Support a robust community engagement effort and outreach to underrepresented groups
 - ► Include language on climate mitigation and resiliency into plan
 - ► Improve goals around farmland preservation
 - ▶ Update plan to meet housing needs
 - ► Add in environmental justice priority
 - ► Address racial disparities
 - ► Include measurable metrics
 - Consider updates to County-Wide Planning Policies

Thurston 2045 Survey Report

▶ Top priorities of the community identified in survey:



Protect sensitive areas like wildlife habitat, flood areas, landslide areas, and surface and ground water (57%).



Prepare for climate change and take actions towards reducing impacts (47%).



Protect agriculture (36%).



Increase availability of affordable housing (33%).



Required Updates

- ▶ Parks and Recreation Element
- ► Land Use and Zoning Corrections
- ▶ Joint Plan Updates (Tenino and Rainier)
- ▶ Development Regulations to meet changes in state law




Optional Updates
