Thurston 2045: the County's Periodic Update

- ▶ Updates required periodically (ten-year cycle) to land use, population, building, and housing data
- ▶ 20-year horizon to 2045
- ▶ Ensures consistency with Washington State Growth Management Act
- ▶ Not a full repeal and replace, or a full re-visioning
- ▶ Next periodic update due December 31, 2025

What is a Comprehensive Plan?

- ▶ Sets guiding principles and vision for how and where development occurs
- ▶ Guided by 15 Planning Goals:
 - ▶ Concentrate urban growth
 - ▶ Reduce sprawl
 - ▶ Transportation
 - ▶ Affordable housing
 - ▶ Economic development
 - ▶ Property rights
 - ▶ Predictable permitting
 - ▶ Natural resource industries
 - ▶ Open Space and recreation
 - ▶ Environmental protection
 - ▶ Citizen participation and coordination
 - ▶ Public facilities and services
 - ▶ Historic preservation
 - ▶ Climate change and resiliency
 - ▶ Shoreline management

Last periodic update complete in 2019, based on 2016 data


