Thurston County Environmental Health Updates

This memorandum is being sent out to sewage system designers, installers and other interested parties to let folks know of updates that are occurring within Thurston County Public Health and Social Services Department, Environmental Health Division.

- The entire Public Health and Social Services Department has received new telephone numbers. If you dial one of our existing phone numbers, a message indicates that the number no longer exists and informs you of the new number. Our general telephone numbers can be found on our website: http://www.co.thurston.wa.us/health/global/contopics.html#eh
- A new version of Thurston County's Sanitary Codes, Article I and IV, will go into effect on January 1, 2010. Please be sure to review the new regulations, as they will apply to sewage system permit applications submitted after January 1, 2010. The new regulations can be found on our website: http://www.co.thurston.wa.us/health/ehadm/index.html

Some of the major changes to the sanitary code include: Mandatory submission of pumper reports and associated fees Inspections of septic systems when property sells Risers and access ports at or above finished grade

The Department is also implementing some of the current Recommended Standard and Guidance Documents published by the Washington State Department of Health, as they are written, with few exceptions. The documents include July 2009 Pressure Distribution, July 2009 Mound, July 2009 Sand Lined Trench and July 2007 Intermittent Sand Filter System.

Several of the guidelines require the sewage system designer to develop and submit a "user's manual" for the sewage system. The Department will continue to fulfill this responsibility as we have in the past, through our operational certificate program.

Mound reserve areas will still need to be staked for our field evaluations.

Please be sure to review the new guidance documents listed on the previous page, as they will apply to sewage system permit applications submitted after February 1, 2010. The previous policies will be cancelled as of February 1st. The new documents can be found Department Health website: the Washington State of on http://www.doh.wa.gov/ehp/ts/WW/pubs-ww-topic.htm#RS&Gs. I have included with this memo a new Sand Lined Trench policy.

- Washington State Department of Health has adopted new sewage tank rules. Chapter 246-272C WAC, On-site Sewage System (OSS) Tanks is adopted, final, and became effective December 19, 2009. You may find the document on their website: http://www.doh.wa.gov/ehp/ts/WW/tanks/tanks-rap.htm
- Listed below are various types of permit application scenarios and the associated fees that will be due for each at the time of submittal. This structure will take effect on January 1, 2010.

Proposal Sand Filter Rebuild or

Mound Rebuild

Applicable Fees Application fee Installation Permit fee

Operation & maintenance education fee Operational Certificate renewal fee*

Sand Filter Bypass

Application fee Operational Certificate renewal fee*

Change in Treatment Unit (example: sand filter to ATU or adding treatment unit to an existing system)

Application fee Installation Permit fee Operation and maintenance education fee Operational Certificate renewal fee*

Change in disinfection method (example: chlorination to ultraviolet)

Application fee Operational Certificate renewal fee*

*If the existing Operational Certificate is not expired, or if the property is in the Henderson Watershed Protection District, the Operational Certificate renewal fee will not be needed.
