2. Joe Hanna provided an update on WA Senate Bill 5045. The bill was rewritten again. Part of the rewrite included in Section 2, meat and poultry marketing assistance program.

creating a new program and taking out of department of agriculture. Moved away from processing meat to economic development and marketing. Section 3 appears the program will be under conservation rather than agriculture. Discusses conservation districts being able to do mobile slaughter. - 6. Potential County Agricultural Coordinator/Laison The TCAAC may want to consider making a recommendation to the county commissioner on what the position looks like.

Public Comment: Eric – no overtime exemption on any dairy and retroactive pay for the last 3 years. Considered for those dairies who worked employees over 40 hours, this will include time over and missed meals. Many dairies are considering moving away from dairy farming. (labor & compensation issue? Or an issue that may creep over to non-dairy farmers). Eric and one other local farmer have had offers to put Solar Panels on some of their farm land by PSE rep.

WSU Update – Information regarding the grain project, capital budget request at the Port of Chehalis. Food Hub is looking for chicken/beef/eggs for sale and pushing to look for buyer to sell products consistently. Received funding from Port of Olympia, the Port supported purchase of equipment to move the Food Hub forward. Extension has a few proposals: possible funding from Sentinel Landscapes Partnership to support habitat and market development. Other initiatives: Western Coast Restoration and Recovery Initiative – potential to develop livestock producers. Written update will be provided.
