Background

Registered voter PAUL EDWIN BROWN, 11/8/1956, is registered with a residence address of 4900 15th Ave SE in Lacey, WA and a status of Active. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

Previous History

The Washington Voter Research Project originally canvassed this address on November 22, 2021. At the time, resident Bethany Hollander indicated that 3 voters registered to this address, including BROWN, did not reside there, stating "I've lived here four years and none of them have lived here," indicating that BROWN has not lived at that address since November 22, 2017 or earlier. The VRDB lists this voter's registration date as 11/16/2017.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. BROWN was on this list. However, BROWN's voter registration is unchanged. This voter, or someone using this voter's identity, continued to vote using this residence address and voted in the November 2022 election despite not having resided at this address since November 2017 or earlier.

Given that the voter does not reside at this address, and has no separate mailing address in the VRDB, it is unclear how this voter was able to obtain their ballot.

Affidavit

On May 19, 2023 affiant Avarie Gibson, at 4900 15th Ave SE, Lacey WA 98503, signed an affidavit declaring that registered voter PAUL E BROWN does not reside at that address.

Letter

On May 22, 2023 I mailed a letter via USPS First Class postage with Return Service Requested to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelope

On May 26, 2023 the letter to the address on file was returned to me as undeliverable.

Data obtained from this source on 6/16/23 shows PAUL E BROWN, with an age consistent with the birthdate listed in the VRDB, at the address of 4900 15th Ave SE in Lacey, WA. This source lists several other possible addresses, including 4596 Williams Valley Rd in Clayton, WA 99110, as well as a landline telephone number of (253) 759-4284.

Source 2: Cyber Background Checks

Data obtained from this source on 6/16/23 shows an PAUL E BROWN, with an age consistent with the birthdate listed in the VRDB, at 4900 15th Ave SE in Lacey, WA and several possible phone numbers.

Source 3: Thurston County Assessor Parcel Search <https://tcproperty.co.thurston.wa.us/propsql/front.asp>

An Assessor Parcel Search conducted on 4/23/23 shows that PAUL E BROWN does not own any real property in Thurston County, WA.

Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 6/12/23, shows no other registered voters in WA state with the name PAUL BROWN and birthdate of 11/8/56. The data also shows that BROWN last voted on November 8, 2022.

Source 5: VoteRef <https://voteref.com/>

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name PAUL E BROWN and/or PAUL EDWIN BROWN having a birthdate of November 8, 1956. There is a PAUL EDWIN BROWN registered in Alabama that is 67 years old, which is one year off from BROWN's current age of 66.

Source 6: Thurston County Corrections Facility Roster

As of 6/15/23, the Thurston County Corrections Facility Roster search shows no current inmates with the last name of BROWN.

Source 7: Washington DOC Inmate Search: <https://www.doc.wa.gov/information/inmate-search/>

As of 6/16/23, the Washington Department of Corrections search shows no current incarceration for PAUL E BROWN. There is an inmate named Paul R Brown, but the middle initial differs from BROWN's and the age of 67 is not consistent with BROWN's birthdate of 11/8/1956.

Source 8: Federal Bureau of Prisons <https://www.bop.gov/inmateloc/>

As of 6/16/23, the Federal Bureau of Prisons Inmate Locator shows no incarceration on record for PAUL EDWIN BROWN. The individuals named Paul Brown in the search results have ages and middle initials that do not match those of BROWN.

Conclusion

An affidavit was obtained attesting that PAUL EDWIN BROWN does not currently reside at 4900 15th Ave SE in Lacey, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter at the address listed in the VRDB was returned undeliverable.

This voter meets the requirements for a successful voter challenge.
