Background

Registered voter LISA ANN DALEBOUT, 11/23/1971, is registered with a residence address of 3914 14th Ct NE in Olympia, WA and a status of Active. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

Previous History

The Washington Voter Research Project originally canvassed this address on November 2, 2021. At the time, resident Sarah Clark indicated that DALEBOUT had moved out in August 2020.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. DALEBOUT was on this list. However, DALEBOUT's voter registration is unchanged. This voter, or someone using this voter's identity, continued to vote using this residence address and voted in the November 2022 election, despite having moved out in August 2020.

Given that there is no separate mailing address on file in the VRDB, it is unclear how this voter obtained their ballot.

Affidavit

On April 26, 2023 affiant Elijah Orcutt, at 3914 14th Ct NE in Olympia, WA, signed an affidavit declaring that registered voter LISA A DALEBOUT does not reside at that address.

Letter

On May 4, 2023 I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelopes

On or about May 10, 2023 the letter to the residence address in the VRDB was returned to me as "Attempted – Not Known".

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 6/12/23, shows no other registered voters in WA state with the name LISA DALEBOUT or LISA NILES and birthdate of 11/23/1971. The data also shows that DALEBOUT last voted on November 8, 2022.

Conclusion

An affidavit was obtained attesting that LISAA DALEBOUT does not currently reside at 3914 14th Ct NE in Olympia, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter to the residence address listed in the VRDB was returned marked "Attempted – Not Known." A potential new address of 4510 23rd Ave SE in Lacey, in Lacey was found in online databases but the veracity of this information is doubtful given the unusual pattern of addresses in the record. It is possible DALEBOUT goes by the last name NILES.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810.


