## 11818105 – PAUL I OTTWELL: Voter Challenge Summary

### Background

Registered voter PAUL I OTTWELL, 9/11/1957, is registered with a residence address of 5815 Lacey Blvd SE in Lacey, WA and a status of Inactive. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

### Previous History

The Washington Voter Research Project originally canvassed this address on September 28, 2021. At the time, the canvasser noted that this location is the Lacey Post Office, a nonresidential address.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. OTTWELL was on this list. However, OTTWELL's voter registration is unchanged.

### Affidavit

On April 26, 2023 affiant Aaron Robinson, postal manager at 5815 Lacey Blvd SE, signed an affidavit declaring that registered voter PAUL I OTTWELL does not reside at that address.

### Letter

On May 22, 2023 I mailed a letter via USPS First Class Mail with Return Service Requested to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

### Envelopes

On or about June 4, 2023 the letter to the residence address in the VRDB was returned to me as "Insufficient Address – Unable to Forward".

### Data Searches

Data obtained from this source on 6/17/23 shows PAUL I OTTWELL, with an age consistent with the birthdate listed in the VRDB, at the address of 309 N Memorial St, Apt 1, in Pittsfield, IL 62363. Previous addresses in Thurston County are listed in this record.

#### Source 2: Cyber Background Checks <https://www.cyberbackgroundchecks.com/>

Data obtained from this source on 6/17/23 shows PAUL I OTTWELL, with an age consistent with the birthdate listed in the VRDB, at the address of 309 N Memorial St, Apt 1, in Pittsfield, IL 62363. Previous addresses in Thurston County are listed in this record.

#### Source 3: Thurston County Assessor Parcel Search <https://tcproperty.co.thurston.wa.us/propsql/front.asp>

An Assessor Parcel Search conducted on 6/17/23 shows that there is no real property in Thurston County owned by PAUL OTTWELL.

#### Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 6/12/23, shows no other registered voters in WA state with the name PAUL OTTWELL and birthdate of

9/11/1957. The “LastVoted” column is null, indicating the PAUL OTTWELL has not voted in any recent elections.

### Source 5: VoteRef <https://voteref.com/>

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name PAUL OTTWELL having a birthdate of 9/11/1957. However, the VoteRef website does not contain records from the State of Illinois, where **Source 1** and **Source 2** indicate OTTWELL may currently be residing. See **Source 9** for Illinois voter registration search results.

### Source 6: Thurston County Corrections Facility Roster

As of 6/17/23, the Thurston County Corrections Facility Roster search shows no current inmates with the last name of OTTWELL.

As of 6/17/23, the Washington Department of Corrections search shows no current incarceration for anyone named PAUL OTTWELL.

As of 6/17/23, the Federal Bureau of Prisons Inmate Locator shows no incarcerations for PAUL OTTWELL.

### Source 9: Illinois State Board of Elections

A search of this source on 6/17/23 for PAUL OTTWELL at the address listed in **Source 1** and **Source 2** returned the result “Paul Ottwell’s REGISTRATION STATUS COULD NOT BE RESOLVED.”

### Conclusion

An affidavit was obtained attesting that PAUL I OTTWELL does not currently reside at 5815 Lacey Blvd SE in Lacey, WA, which is a nonresidential address. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter to the residence address listed in the VRDB was returned marked “Insufficient Address – Unable to Forward”. A potential new address of 309 N Memorial St, Apt 1, in Pittsfield, IL 62363 was found in online databases.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810.

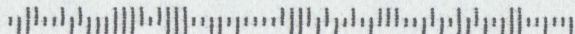
