Background

Registered voter KONNER GABRIEL SHRIVER, 2/8/1998, is registered with a residence address of 4318 5TH Ave NW in Olympia, WA and a status of Active. There is a mailing address on file for this voter in the Voter Registration Database (VRDB) of 15013 NE 9th Pl in Bellevue, WA.

Previous History

The Washington Voter Research Project originally canvassed this address on October 6, 2021. Alana J Bloomdahl stated that Bloomdahl had moved in around September 2020, and doesn't know who Shriver is. This indicates that SHRIVER has not lived at this address since September 2020 or earlier.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. SHRIVER was on this list. However, SHRIVER's voter registration is unchanged. This voter, or someone using this voter's identity, continued to vote using this residence address including in the recent April 2023 special election, despite not having resided there since September 2020 or earlier.

Affidavit

On April 27, 2023 affiant Alana Bloomdahl, at 4318 5th Ave NW in Olympia, WA, signed an affidavit declaring that registered voter KONNER G SHRIVER does not reside at that address.

Letter

On May 4, 2023 I mailed a letter via USPS Certified Mail to the residence and mailing addresses on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelopes

On or about May 29, 2023 the letter to the mailing address in the VRDB was returned to me as unclaimed. On or about June 1, 2023 the letter to the residence address in the VRDB was returned to me as unclaimed.

Data obtained from this source on 4/22/23 failed to return a search result for KONNER SHRIVER, showing two other individuals named Shriver whose ages are not consistent with the voter's date of birth listed in the VRDB.

Data obtained from this source on 4/22/23 failed to return a search result for KONNER SHRIVER, showing four females named Shriver whose ages and genders are not consistent with the voter's date of birth and gender listed in the VRDB.

An Assessor Parcel Search conducted on 4/22/23 shows that there is no real property in Thurston County owned by KONNER SHRIVER.

Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 6/12/23, shows no other registered voters in WA state with the name KONNER SHRIVER. The data also shows that SHRIVER last voted on April 25, 2023.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name KONNER SHRIVER.

As of 6/17/23, the Thurston County Corrections Facility Roster search shows no current inmates with the last name of SHRIVER.

As of 6/17/23, the Washington Department of Corrections search shows no current incarceration for anyone named KONNER SHRIVER.

As of 6/17/23, the Federal Bureau of Prisons Inmate Locator shows no incarcerations for KONNER SHRIVER.

Source 9: Facebook

A search of Facebook.com on 4/22/23 revealed a profile for KONNER SHRIVER at <https://www.facebook.com/konner.shriver>. The Facebook profile indicates that SHRIVER lives in Vancouver, WA. The photographs appear consistent with the demographic characteristics (25-year-old male) listed for SHRIVER in the VRDB.

Conclusion

An affidavit was obtained attesting that KONNER G SHRIVER does not currently reside at 823 4318 5TH Ave NW in Olympia, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letters to the residence and mailing addresses listed in the VRDB were returned unclaimed. A Facebook profile for KONNER SHRIVER suggests he may reside in Vancouver, WA.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810.
