Background

Registered voter KENSHAWN QWENTES MULDROW, 11/18/1992, is registered with a residence address of 5815 Lacey Blvd SE in Lacey, WA and a status of Inactive. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB). The voter last voted on 11/3/2020.

Previous History

The Washington Voter Research Project originally canvassed this address on September 28, 2021. At the time, the canvasser noted that this location is the Lacey Post Office, a nonresidential address.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. MULDROW was on this list. However, MULDROW's voter registration address is unchanged.

Affidavit

On April 26, 2023 affiant Aaron Robinson, postal manager at 5815 Lacey Blvd SE, signed an affidavit declaring that registered voter KENSHAWN Q MULDROW does not reside at that address.

Letter

On May 22, 2023 I mailed a letter via USPS First Class Mail with Return Service Requested to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelopes

On or about June 4, 2023 the letter to the residence address in the VRDB was returned to me as "Insufficient Address – Unable to Forward".

An Assessor Parcel Search conducted on 6/17/23 shows that there is no real property in Thurston County owned by KENSHAWN MULDROW.

Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 6/12/23, shows no other registered voters in WA state with the name KENSHAWN MULDROW and birthdate of 11/18/1992.

Conclusion

An affidavit was obtained attesting that KENSHAWN Q MULDROW does not currently reside at 5815 Lacey Blvd SE in Lacey, WA, which is a nonresidential address. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter to the residence address listed in the VRDB was returned marked "Insufficient Address – Unable to Forward". A potential new address of 4904 Mullen Heights Dr SE in Olympia, WA 98513 was found in online databases.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810.





(A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;

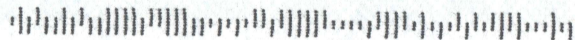
