### Background

Registered voter ANGELA JOYE DREES, 9/13/1978, is registered with a residence address of 9607 Glory Dr SE in Olympia, WA and a status of Active. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

### **Previous History**

According to the USPS NCOA database, a change of address was filed in May 2022 for ANGELA DREES to the new address of 1966 W Teano Dr. in Meridian, ID 83646.

### **Affidavit**

On June 7, 2023 a resident at 9607 Glory Dr. SE in Olympia, WA signed an affidavit declaring that registered voter ANGELA J DREES does not reside at that address.

### Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. This voter meets the requirements for a successful voter challenge.


