Previous History

According to the USPS NCOA database, a change of address was filed in June 2021 for HAZEL SHERWOOD to the new address of 5707 E 32nd St Lot 623 in Yuma, AZ 85365.

Affidavit

On June 12, 2023 a staff member at 9101 Steilacoom Rd SE in Olympia, WA signed an affidavit declaring that registered voter HAZEL Y SHERWOOD does not reside at that address.

Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. 
