Background

Registered voter CHRIS G WEAVER, 2/11/1982, is registered with a residence address of 5816 188th Ave SW in Rochester, WA and a status of Active. There is a separate mailing address on file for this voter in the Voter Registration Database (VRDB) of PO Box 156 in Rochester, WA 98579.

Previous History

According to the USPS NCOA database, a change of address was filed in **August 2019** for CHRIS WEAVER to a new address of 2022 McKay Ln in Billings, MT 59102.

The Washington Voter Research Project originally canvassed this address on November 19, 2021. No one answered the door, but the canvasser noted that Thurston County Assessor records indicated that WEAVER sold this property to Duffrin on 8/12/2019. The canvasser also noted that there was a sign on the house that said "Duffrin".

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. WEAVER was on this list. However, WEAVER's voter registration is unchanged.

Affidavit

On June 4, 2023 a resident at 5816 188th Ave SW in Rochester, WA signed an affidavit declaring that registered voter CHRIS G WEAVER does not reside at that address.

Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to both of the addresses on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelope

On July 12, 2023 the letter to the residence address on file was returned to me as NOT DELIVERABLE AS ADDRESSED UNABLE TO FORWARD. On July 18 2023 the letter to the mailing address on file was returned to me as NOT DELIVERABLE AS ADDRESSED UNABLE TO FORWARD.

An Assessor Parcel Search conducted on 8/15/23 shows that CHRIS WEAVER does not own real property in Thurston County. A search of the address 5816 188th Ave SW shows that CHRISTOPHER G WEAVER and Brenna C Weaver sold this property to Todd & Gloria Duffrin on 8/12/19.

Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 8/3/23, shows no other registered voters in WA state with the name CHRIS G WEAVER or CHRISTOPHER G WEAVER in Washington that were born in 1982. The data indicates that WEAVER last voted in November 2020.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name CHRIS G WEAVER or CHRISTOPHER G WEAVER with a matching birthdate of 2/11/1982. VoteRef records include the state of Montana.

Conclusion

An affidavit was obtained from a resident attesting that CHRIS G WEAVER does not currently reside at 5816 188th Ave SW in Rochester, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The voter sold the subject property in August 2019. The USPS NCOA database indicates that the voter changed address to 2022 McKay Ln in Billings, MT 59102 in August 2019. The letter to the voter at the address listed in the VRDB was returned marked UNCLAIMED UNABLE TO FORWARD. Online database searches revealed a possible address of 2022 McKay Ln in Billings, MT 59102.

This voter meets the requirements for a successful voter challenge.
