Background

Registered voter KEVIN M ARRAS, 11/8/1962, is registered with a residence address of 3601 Arbor Dr SE in Lacey, WA and a status of Active. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

Previous History

According to the USPS NCOA database, a change of address was filed in **October 2022** for KEVIN ARRAS to a new address of 8729 Windhaven Rd in Ooltewah, TN 37363.

Affidavit

On June 15, 2023 a resident at 3601 Arbor Dr SE in Lacey, WA signed an affidavit declaring that registered voter KEVIN M ARRAS does not reside at that address.

Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelope

On July 22, 2023 the letter to the residence address on file was returned to me as ATTEMPTED – NOT KNOWN UNABLE TO FORWARD.

An Assessor Parcel Search conducted on 8/2/23 shows that KEVIN ARRAS does not own real property in Thurston County. A search of the address 3601 Arbor Dr SE shows that ARRAS sold the subject property to Nathan & Justine Witzl on **1/24/23**.

Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 8/3/23, shows no other registered voters in WA state with the name KEVIN ARRAS or MARK ARRAS in Washington that were born in 1962. The data indicates that ARRAS last voted in November 2022.

Conclusion

An affidavit was obtained from a resident attesting that KEVIN M ARRAS does not currently reside at 3601 Arbor Dr SE in Lacey, WA. The voter sold this property in January 2023. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is registered to vote in Tennessee. USPS NCOA database indicates that the voter changed address to 8729 Windhaven Rd in Ooltewah, TN 37363 in October 2022. The letter to the voter at the address listed in the VRDB was returned marked ATTEMPTED – NOT KNOWN UNABLE TO FORWARD. Online database searches, including VoteRef, confirm the new address of 8729 Windhaven Rd in Ooltewah, TN 37363.

This voter meets the requirements for a successful voter challenge.

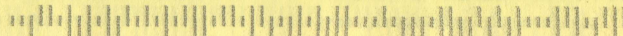

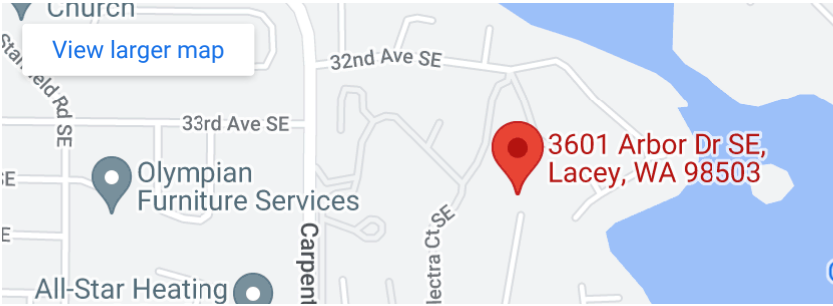

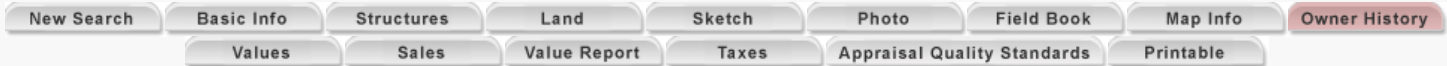
