## 12627404 – BREANNA NICOLE BOGGS: Voter Challenge Summary

### Background

Registered voter BREANNA NICOLE BOGGS, 10/24/1998, is registered with a residence address of 1608 Cyrene Dr NW in Olympia, WA and a status of Active. The July 3 2023 version of the Voter Registration Database (VRDB) lists a separate mailing address of PO Box 11582 Olympia, WA 98508, but this mailing address is not present in the August 3 2023 version of the VRDB.

### Previous History

According to the USPS NCOA database, a change of address was filed in **October 2020** for BREANNA BOGGS to a new address of 15075 SE STARK ST APT 202 PORTLAND OR 97233.

The Washington Voter Research Project originally canvassed this address on December 6, 2021. At the time, resident Lawrence Boggs indicated that BOGGS is his daughter and moved to Portland in October 2020.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. BOGGS was on this list, as was Lawrence Bogg's comment that BOGGS had moved to Portland. However, BOGGS's voter registration is unchanged.

### Affidavit

On June 5, 2023 a resident at 1608 Cyrene Dr NW in Olympia, WA signed an affidavit declaring that registered voter BREANNA N BOGGS does not reside at that address. The resident told the canvasser that BOGGS is his daughter.

### Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to both addresses on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

### Envelope

On July 9, 2023 the letter to the residence address on file was returned to me as NOTIFY SENDER OF NEW ADDRESS BOGGS PO BOX 11582 OLYMPIA, WA 98508. Subsequently, the letter to the mailing address of PO Box 11582 in Olympia, WA 98508 was also returned to me, without a yellow sticker.

### **Source 3: Thurston County Assessor Parcel Search** <https://tcproperty.co.thurston.wa.us/propsql/front.asp>

An Assessor Parcel Search conducted on 9/4/23 shows that BREANNA BOGGS does not own real property in Thurston County. There is real property owned by a person named Breann Boggs, but this is a different person with a date of birth in 1981.

### **Source 4: Washington Voter Registration Database Extract**

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 8/3/23, shows no other registered voters in WA state with the name BREANNA BOGGS born in 1998. The data indicates that the voter last voted in November 2020.

The VoteRef website, containing the voter registration databases of at least 30 states including Oregon, shows no other voters named BREANNA BOGGS with a matching birth year.

As of 9/4/23, the Thurston County Corrections Facility Roster search shows no current inmates with the name of BOGGS.

As of 8/12/23, the Federal Bureau of Prisons Inmate Locator shows no incarceration on record for BREANNA BOGGS.

### **Conclusion**

An affidavit was obtained from a resident attesting that BREANNA N BOGGS does not currently reside at 1608 Cyrene Dr NW in Olympia, WA. The USPS NCOA database indicates that the voter changed address to 15075 SE STARK ST APT 202 PORTLAND OR 97233 in October 2020. The data indicates that the voter does not own property in Thurston County, and is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter at the addresses listed in the VRDB was returned. This voter meets the requirements for a successful voter challenge.
