## 8451539 – CHARLES THOMAS UTLEY: Voter Challenge Summary

### Background

Registered voter CHARLES THOMAS UTLEY, 1/25/1954, is registered with a residence address of 4709 14<sup>th</sup> Ave SE in Lacey, WA and a status of Active. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

### Previous History

According to the USPS NCOA database, a change of address was filed in **September 2022** for CHARLES UTLEY to a new address of 132 W PARK ST OXFORD NY 13830.

### Affidavit

On June 15, 2023 a resident at 4709 14<sup>th</sup> Ave SE in Lacey, WA signed an affidavit declaring that registered voter CHARLES T UTLEY does not reside at that address.

### Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

### Envelope

On July 18, 2023 the letter to the residence address on file was returned to me as RETURN TO SENDER UNABLE TO FORWARD.

Data obtained from this source on 7/31/23 shows CHARLES T UTLEY, with an age consistent with the birthdate listed in the VRDB, at the address of 132 W Park St in Oxford, NY 13830. Prior addresses in Thurston County are listed, including 4709 14<sup>th</sup> Ave SE in Lacey.

#### Source 3: Thurston County Assessor Parcel Search <https://tcproperty.co.thurston.wa.us/propsql/front.asp>

An Assessor Parcel Search conducted on 9/4/23 shows that CHARLES UTLEY does not own real property in Thurston County.

#### Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 8/3/23, shows no other registered voters in WA state with the name C UTLEY that were born in 1954. The data indicates that CHARLES UTLEY last voted in November 2022.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no out of state voter registrations for CHARLES THOMAS UTLEY or CHARLES T UTLEY with a matching birth year of 1954.

As of 7/31/23, the Thurston County Corrections Facility Roster search shows no current inmates with the name of UTLEY.

As of 7/31/23, the Washington Department of Corrections search shows no current incarceration for CHARLES UTLEY.

As of 9/4/23, the Federal Bureau of Prisons Inmate Locator shows no incarceration on record for CHARLES UTLEY.

### Conclusion

An affidavit was obtained from a resident attesting that CHARLES T UTLEY does not currently reside at 4709 14<sup>th</sup> Ave SE in Lacey, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The USPS NCOA database indicates that the voter changed address to 132 W Park St in Oxford, NY 13830 in September 2022. The letter to the voter at the address listed in the VRDB was returned marked RETURN TO SENDER UNABLE TO FORWARD. Online database searches confirm the new address of 132 W Park St in Oxford, NY 13830.

This voter meets the requirements for a successful voter challenge.

(A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;

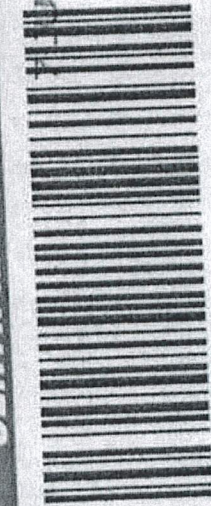
