## 11015530-MOLLY JO ANDERSON: Voter Challenge Summary

### Background

Registered voter MOLLY JO ANDERSON, 5/25/1994, is registered with a residence address of 4007 56<sup>th</sup> Trl SE in Olympia, WA and a status of Active. This address is an apartment complex, but there is no apartment number listed and no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

### Affidavit

On June 8, 2023 a maintenance worker at 4007 56<sup>th</sup> Trl SE in Olympia, WA signed an affidavit declaring that registered voter MOLLY J ANDERSON does not reside at that address.

### Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

### Envelope

On July 13, 2023 the letter to the residence address on file was returned to me as NOT DELIVERABLE AS ADDRESSED UNABLE TO FORWARD.

An Assessor Parcel Search conducted on 9/4/23 shows that MOLLY ANDERSON does not own real property in Thurston County.

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 8/3/23, shows no other registered voters in WA state with the names MOLLY ANDERSON that were born in 1994. The data indicates that the voter has never voted.

### Conclusion

An affidavit was obtained from a maintenance worker attesting that MOLLY J ANDERSON does not currently reside at 4007 56<sup>th</sup> Trl SE in Olympia, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in one of the 30+ states covered by VoteRef. The letter to the voter at the address listed in the VRDB was returned marked NOT DELIVERABLE AS ADDRESSED UNABLE TO FORWARD.

This voter meets the requirements for a successful voter challenge.

(A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;




