Background

Registered voter MOLLY JO ANDERSON, 5/25/1994, is registered with a residence address of 4007 56th Trl SE in Olympia, WA and a status of Active. This address is an apartment complex, but there is no apartment number listed and no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

Affidavit

On June 8, 2023 a maintenance worker at 4007 56th Trl SE in Olympia, WA signed an affidavit declaring that registered voter MOLLY J ANDERSON does not reside at that address.

Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.


