#### 12949821 - SCOTT PAUL COLE: Voter Challenge Summary

#### Background

Registered voter SCOTT PAUL COLE, 9/21/1987, is registered with a residence address of 6418 57<sup>th</sup> Ave SE in Lacey, WA and a status of Active. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

#### **Affidavit**

On June 8, 2023 a resident at 6418 57<sup>th</sup> Ave SE in Lacey, WA signed an affidavit declaring that registered voter SCOTT P COLE does not reside at that address.

#### Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

#### Envelope

On July 26, 2023 the letter to the residence address on file was returned to me as RETURN TO SENDER UNCLAIMED UNABLE TO FORWARD.

An Assessor Parcel Search conducted on 8/12/23 shows that an individual named Scott Cole owns a property located at 10701 Umtanum St SE in Yelm. According to the VRDB this is a different registered voter named Scott Blauding Cole, who was born in 1981. The challenged voter was born in 1987. No other individuals named Scott Cole are listed in the search results.

#### Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 9/5/23, shows no other registered voters in WA state with the name SCOTT COLE that were born in 1987. The data indicates that SCOTT PAUL COLE last voted in November 2022. The Extract also lists a Scott Blauding Cole at 10701 Umtanum St SE in Yelm, WA.

# Source 5: VoteRef https://voteref.com/

The VoteRef website, containing the voter registration databases of at least 30 states, shows four out of state voter registrations for Scott P Cole. One Scott P Cole in Louisiana does not have a matching age to SCOTT PAUL COLE. There is no age/DOB listed for the other three Scott P Coles, all of whom are in Wisconsin. Further search of these three Wisconsin voters on Search People Free indicates that none of them were born in 1987.

As of 8/12/23, the Thurston County Corrections Facility Roster search shows no current inmates with the name of COLE.

As of 8/12/23, the Federal Bureau of Prisons Inmate Locator shows no incarceration on record for SCOTT P COLE.

#### Conclusion

An affidavit was obtained from a resident attesting that SCOTT P COLE does not currently reside at 6418 57<sup>th</sup> Ave SE in Lacey, WA. The data indicates that the voter does not own property in Thurston County and is not registered to vote from another address in Washington state. There are three Scott P Coles registered in Wisconsin, but their dates of birth do not match the challenged voter. The letter to the voter at the address listed in the VRDB was returned marked RETURN TO SENDER UNCLAIMED UNABLE TO FORWARD. Online database searches suggest a possible new address of 1512 Bowman Ave NW in Olympia, WA.

This voter meets the requirements for a successful voter challenge.



- (A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;
