Background

Registered voter ANESH NAVEEN MARK ANDRUS, 4/5/2005, is registered with a residence address of 7113 Rothenberg Dr SW in Tumwater, WA and a status of Active. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

The VRDB indicates that this voter registered to vote on 10/19/21, when the voter was 16 years old, and that the voter has not voted in any elections.

Affidavit

On June 7, 2023 a resident at 7113 Rothenberg Dr SW in Tumwater, WA signed an affidavit declaring that registered voter ANESH N ANDRUS does not reside at that address.

Letter

On July 7, 2023 a letter was sent to the voter via USPS Certified Mail to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelope

On August 5, 2023 the letter to the residence address on file was returned to me as RETURN TO SENDER UNCLAIMED UNABLE TO FORWARD.

An Assessor Parcel Search conducted on 9/17/23 shows that ANESH ANDRUS does not own real property in Thurston County. A second search revealed the registered residence address of 7113 Rothenberg Dr SW was sold on June 13, 2022, which is after ANDRUS's voter registration date of 10/19/21.

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 9/5/23, shows no other registered voters in WA state with the name ANESH ANDRUS. T

Conclusion

An affidavit was obtained from a resident attesting that ANESH N ANDRUS does not currently reside at 7113 Rothenberg Dr SW in Tumwater, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The voter's registered residence address was sold in June 2022, subsequent to this voter's registration to vote from that address in October 2021. The letter to the voter at the address listed in the VRDB was returned marked RETURN TO SENDER UNCLAIMED UNABLE TO FORWARD. The voter could not be located in online database searches.

This voter meets the requirements for a successful voter challenge.

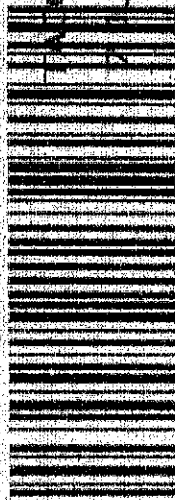

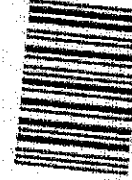

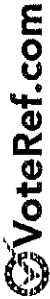
