Background

Registered voter ANDREW WEATHERSPOON MACDONALD, 5/8/1980, is registered with a residence address of 1925 Berry St NE in Olympia, WA and a status of Active. There is a separate mailing address on file for this voter in the Voter Registration Database (VRDB) of 1037 NE 65th St PMB 81007, Seattle, WA 98115.

Previous History

According to the USPS NCOA database, a change of address was filed in **August 2019** for ANDREW MACDONALD.

The Washington Voter Research Project originally canvassed this address on November 26, 2021. At that time the resident stated to the canvasser, "We moved in August 2019." When asked about MACDONALD, the resident stated "He doesn't live here."

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. MACDONALD was on this list. However, MACDONALD's voter registration is unchanged.

Affidavit

On April 29, 2023 a resident at 1925 Berry St NE in Olympia, WA signed an affidavit declaring that registered voter ANDREW W MACDONALD does not reside at that address.

Letter

On July 7, 2023 letters were sent to the voter via USPS Certified Mail to both addresses on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelope

On July 12, 2023 the letter to the residence address on file was returned to me marked RETURN TO SENDER NOT DELIVERABLE AS ADDRESSED UNABLE TO FORWARD. As of September 17, 2023 the letter to the mailing address on file has not been received. USPS tracking information indicates that since May 12, 2023 the letter has been "In Transit to Next Facility, Arriving Late."

An Assessor Parcel Search conducted on 9/11/23 shows that ANDREW MACDONALD does not own real property in Thurston County. Further research of the property at 1925 Berry St NE in Olympia, WA indicates that former owner Alan Macdonald sold this property in September 2019.

Source 4: Washington Voter Registration Database Extract

The Washington State Voter Registration Database Extract, obtained from the Washington Secretary of State on 9/5/23, shows no other registered voters in WA state with the name ANDREW MACDONALD having a birthdate in 1980. The data indicates that MACDONALD last voted in July 2018.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no out of state voter registrations for ANDREW W MACDONALD with a matching birth year of 1980.

Conclusion

An affidavit was obtained from a resident attesting that ANDREW W MACDONALD does not currently reside at 1925 Berry St NE in Olympia, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The USPS NCOA database indicates that the voter changed address in August 2019. The letter to the voter at the residence addresses listed in the VRDB was returned marked RETURN TO SENDER NOT DELIVERABLE AS ADDRESSED UNABLE TO FORWARD. The letter to the mailing address has not been returned. Online database searches indicate an address of 1037 NE 65th St, Unit 81007, in Seattle, WA.

This voter meets the requirements for a successful voter challenge.
