#1 - Thurston County Designated 'SolSmart Silver' for **Solar Energy Leadership**



Thurston County received a 'Silver' designation from the national SolSmart_program for encouraging the growth of clean, affordable solar energy at the local level. As a SolSmart designee, Thurston County adopted nationally recognized best practices to advance solar market growth. The county worked with SolSmart's no-cost technical assistance team to

increase local knowledge of solar energy so the entire community can benefit.

"Solar energy is an important strategy of the <u>Thurston Climate Mitigation Plan</u> to help reduce local greenhouse gas emissions while helping our residents and businesses save money on their utility bills," said Rebecca Harvey, Thurston County's Climate Mitigation Senior Program Manager. "The City of Tumwater also received SolSmart 'Silver' designation this week, which is just one example of how the county is working with the cities toward shared climate goals."

#4 - Thurston County Manager Ramiro Chavez Resigns, Effective October 5



On August 29, Thurston County Manager, Ramiro Chavez submitted his letter of resignation to the Board of County Commissioners, effective October 5. Chavez's last day serving as the County Manager will be Wednesday, October 4. Chavez has accepted a conditional offer with the City of Tacoma as their Public Works Director.

"Being a part of this exceptional team has been a truly remarkable experience, and I am honored to have served as Thurston County Manager. I extend my utmost gratitude to the Board of County Commissioners and the entire staff for their support," said Chavez. He added, "I am confident I have exerted my utmost effort to serve the community to the best of my abilities"

In a two to one vote, the Board of County Commissioners selected Assistant County Manager, Robin Campbell to serve as the Interim County Manager while they move

through the hiring process.

Commissioner Gary Edwards said about his 'no' vote, "I nominated Rob Gelder because he is a new, fresh face at the county." He added, "I believe he would have provided an opportunity for a clean slate and is a well-qualified individual for the interim county manager position, as he is currently serving as one of the assistant county managers."

"Speaking for the board, I want to thank Ramiro for his years of service at Thurston County and his leadership in this role," said Chair of the Board, Carolina Mejia. "We wish him the best of luck in this new chapter."

Now Accepting Applications for the Community Advisory Workgroup

As the Thurston region moves forward to address the climate crisis, let your voice be heard! The Thurston Climate Mitigation Collaborative (TCMC) is now accepting applications for the Community Advisory Workgroup (CAW). Thurston County and the cities of Lacey, Olympia, and Tumwater have come together as the TCMC to create the Thurston Climate Mitigation Plan, which aims to reduce community-wide greenhouse gas emissions 45% by 2030, and 85% by 2050, compared to 2015 levels.

The CAW meets monthly to share community perspectives and provide feedback on strategies and actions to reduce regional greenhouse gas emissions. Experience in climate science or climate policy is not required. We encourage applicants from diverse backgrounds including youth, seniors, tribal members, people with disabilities, people of color, business owners, poor and working-class folks, professionals—in short, anyone who cares about our community and wants to share their perspective on climate solutions! As a member, you can receive compensation of \$50 per meeting, unless you are paid by your employer while attending meetings.
