The voter sold the subject property in September 2022. The USPS NCOA database indicates that the voter changed address to 411 Villa Ave in Front Royal, VA 22630 in September 2022. The letter to the voter at both addresses listed in the VRDB was returned marked UNCLAIMED UNABLE TO FORWARD.
