**Restorative Justice Overview**

Elizabeth Drake gave a presentation. The presentation will be provided with the minutes and online. (Attached to minutes) There were a couple questions, does a victim of a crime have any input, the answer is yes. How old is the program, the answer, fairly new it is a pilot program starting in 2021.

**E2SSB 5536 Implementation Updates**

Brief discussion that data is being collected on trends. Referrals are made to Jason. People with a substance use disorder are eligible to participate. So far, the program is flexible, meeting people's needs and is working with the courts. The sheriff asked his office to be updated as they do not want to fill the jail with simple possession charges.

**Good of the Order**

Commissioner Menser shared Olympia Police Department has a Blake hot line. The Administration Office of the Courts has a Refund Portal. He is on a committee with the Sentencing Guideline Committee that is working on a new sentencing grid, including changes in ranges.
