Project Description: The Inspiring Kids Nature Preserve would establish and operate a children's environmental education center on a parcel located within Shoreline Master Program jurisdiction and encumbered by multiple critical areas. The project would protect multiple shoreline habitats, continue ecosystem restoration work, and provide a nature education platform to local schools that's tailored to area resources.

An application for this project was submitted to Thurston County on September 16, 2020 by the Capitol Land Trust. The application was deemed to be complete for the purpose of beginning the project review on October 6, 2020. Capitol Land Trust - Inspiring Kids Nature Education Preserve

Description of Proposal: The Inspiring Kids Nature Preserve would establish and operate a children's environmental education center on a parcel located within Shoreline Master Program jurisdiction and encumbered by multiple critical areas. The project would protect multiple shoreline habitats, continue ecosystem restoration work, and provide a nature education platform to local schools that's tailored to area resources.

CONDITIONS of APPROVAL:

- Inadvertent Discovery. In the event that archaeological deposits or skeletal material or features of a burial/interment situation are encountered, all work in the vicinity must stop immediately and contact made with the Washington State Historic Preservation Officer, the Nisqually Indian Tribe, any other affected Tribe, and Thurston County Community Planning and Economic Development (CPED).
- 2) <u>Erosion and storm water control Best Practices</u> meeting Thurston County standards; Chapter 15.05 shall be employed during all phases of the project. Proper erosion and sediment control practices shall be used on the construction site and adjacent areas.
- 3) <u>Erosion control measures</u> must be in place prior to any clearing, grading, or construction. These control measures must be effective to prevent stormwater runoff from carrying soil and other pollutants into surface water or stormdrains that lead to waters of the state.
- 4) <u>During construction</u>, all releases of oils, hydraulic fluids, fuels, other petroleum products, paints, solvents, and other deleterious materials must be contained and removed in a manner that will prevent their discharge to waters and soils of the state. The cleanup of spills should take precedence over other work on the site.
- 5) Solid Waste Management. All grading and filling of land must utilize only clean fill. All other materials may be considered solid waste and permit approval may be required from the local jurisdictional health department. All debris must be disposed of at an approved site. Contact the local jurisdictional health department for proper management guidance. Derek Rockett (360) 407-6287.

- 6) <u>U.S. Army Corps Jurisdictional Determination.</u> Ecology recommends that the applicant request a jurisdictional determination from the Corps. If the Corps determines that the wetlands to be impacted are not waters of the U.S., Ecology will regulate the proposed wetland impacts under the State Water Pollution Control Act, RCW 90.48. - 7) Tacoma Smelter Plume / Toxics Cleanup. This proposed project is located in an area that may have been contaminated with heavy metals due to the air emissions originating from the old Asarco smelter in north Tacoma (visit Ecology's Tacoma Smelter Plume map search tool: https://fortress.wa.gov/ecy/smeltersearch/). Soil contamination from the former Asarco smelter poses a risk to human health and the environment. Children are at especially high risk from direct exposure to contaminated soil. Construction workers, landscapers, gardeners, and others who work in the soils are also at risk. Ecology recommends that the lead agency include the following as conditions of approval, prior to the issuance of any site development permits or the initiation of grading, filling, or clearing:
 - Sample the soil and analyze for arsenic and lead following the 2012 Tacoma Smelter Plume Guidance. The soil sampling results shall be sent to Ecology for review. If the project includes open space areas, contact the Technical Assistance Coordinator, Eva Barber, for assistance in soil sampling methodology within the open space area.
 - If lead or arsenic are found at concentrations above the Model Toxics Control Act (MTCA) cleanup levels (Chapter 173-340 WAC); the owners, potential buyers, construction workers, and others shall be notified of their occurrence. The MTCA cleanup level for arsenic is 20 parts per million (ppm) and lead is 250 ppm.
 - If lead, arsenic and/or other contaminants are found at concentrations above MTCA cleanup levels, the applicant shall: 1) Develop soil remediation plan and enter into the Voluntary Cleanup Program with Ecology. For more information on the Voluntary Cleanup Program, visit Ecology's website at: http://www.ecy.wa.gov/programs/tcp/vcp/vcpmain.htm. 2) Obtain an opinion letter from Ecology stating that the proposed soil remediation plan will likely result in no further action under MTCA. The applicant shall provide to the local land use permitting agency the opinion letter from Ecology. 3) Prior to finalizing site development permits, provide to the local land use permitting agency "No Further Action" determination from Ecology indicating that the remediation plans were successfully implemented under MTCA.
 - If soils are found to be contaminated with arsenic, lead, or other contaminants, extra precautions shall be
 taken to avoid escaping dust, soil erosion, and water pollution during grading and site construction. Site
 design shall include protective measures to isolate or remove contaminated soils from public spaces, yards,
 and children's play areas. Contaminated soils generated during site construction shall be managed and
 disposed of in accordance with state and local regulations, including the Solid Waste Handling Standards
 regulation (Chapter 173-350 WAC). For information about soil disposal contact the local health department in
 the jurisdiction where soils will be placed.


This project may require a construction stormwater permit from the WA State Dept. of Ecology (also known as National Pollution Discharge Elimination System (NPDES) and State Waste Discharge General Permit for Stormwater Discharges Associated with Construction). It is the applicant's responsibility to obtain this permit if required.

This permit is required for projects which meet both of the following conditions:

- o One or more acres of soil surface area will be disturbed by construction activities.
- The site already has offsite discharge to waters of the state or storm drains or will have offsite discharge during construction.
