This is a very interesting project. From my understanding some level of cultural resource investigation has occurred along parts of the shorelines within the area of the larger project, however, the higher dry land areas and the southern shoreline have never been investigated. Additionally, this project is broken into two separate phases and contains four known pre-contract archaeological sites. Taking into consideration the scale and scope of the project, we recommend that the applicant hire an archaeologist to conduct a cultural resources investigation of the entire project area, inducing the later phase activities. This investigation should also focus on presence or absence testing for subsurface cultural resources via Shovel Probes. The entire project area is consider to have a very high potential for encountering cultural resources.

Hi Laurence-

My apologies for the delay, I was out in the field. All shovel probes were excavated to hardpan glacial sediments, as discussed in the methodology on pg. 25; "The terminal depth of the probes is dependent upon the geologic conditions encountered during excavation; excavation typically continues until sediments that predate human occupation of the area are encountered. The wide-spread glacial till sediments deposited across the project area during the Vashon Stade of the Fraser Glaciation provide a suitable temporal marker for termination of excavation." The depths that the glacial sediments were encountered across the APE varied due to the amounts of surface disturbances, but a light yellowish brown to pale brown compact glacial stratum present at the base of the probes was excavated into, in most cases, at least two sterile levels (10 cm) into sediments that predate human occupation of the landform.
