I am a resident of Indian Summer Golf & Country Club and Indian Summer Home Owners Association (ISHOA).

Several residents have received the CPED notice regarding the above referenced City of Olympia proposed development next to ISHOA property.

Details on the included site plan graphics are extremely blurred and virtually unreadable.

Another resident, Myrna Lee Hilmo, and I came to your office today to see and/or obtain a legible, clear proposed site plan so we would have the ability to review it in order to provide constructive commentary.

We were expecting knowledgeable staff with an ability to discuss the site plan with us.

When we first explained what our purpose was, two staff at Station #1 told us to go look it up on the CPED website. We then asked them to show us how.

They fumbled around on their computer, had difficulty locating the case, and repeatedly stated they "were not planners" and that we should contact you.

When we asked if you were available they said you were probably busy and to phone or email.

Both of us were taken aback by the their lack of forthcoming, and quite frankly, poor customer service. Their attitude and interface with us bordered on being unprofessional. It appeared, by their behavior and demeanor that they were basically trying to "brush us off".

My fellow resident and I left, determined to obtain this necessary information, particularly in light of the approaching early April 2023 deadline.
