Introduction to Local Measure

For each measure in the Local Voters' Pamphlet, the legislative authority of the jurisdiction placing the measure on the ballot is required to formally appoint committees to prepare statements advocating the approval and rejection of the measure. If the jurisdiction is unable to make such appointments, the Thurston County Auditor advertises for appointments. The Elections Division encourages you to review all statements and seek additional information from the jurisdictions, the appointed citizens' committees and local media.

Yelm Community Schools Proposition No. 1

Replacement Educational Programs and Operations Levy

The Board of Directors of Yelm Community Schools adopted Resolution No. 06-23-24, authorizing a replacement levy to continue support for educational programs. This proposition would authorize the District to levy the following excess taxes, replacing an expiring levy, on taxable property within the District, for educational programs and operation expenses not funded by the State (including special education, nurses, counselors, safety staff, graduation readiness, technology, athletics, and extracurricular activities):

Should this proposition be approved?

Explanatory Statement:

Passage of Proposition No. 1 would allow the Yelm Community Schools to replace an existing educational programs and operations levy that will expire at the end of calendar year 2024. The taxes collected by this levy will be used to pay expenses of educational programs and operations that are not fully funded by the State, including special education, nurses, counselors, school resource officers and safety staff, graduation readiness, technology, athletics, extracurricular activities, and curriculum materials and training.

The proposed four-year replacement levy would authorize the collection of taxes to provide up to \$13,950,000 in 2025, \$14,525,000 in 2026, \$15,100,000 in 2027, and \$15,700,000 in 2028. The tax levy rate required to produce these levy amounts is estimated to be \$2.25 per \$1,000 of assessed value. The exact tax levy rate and amounts to be collected may be adjusted based upon the limitations imposed by State law at the time of the levy. Exemptions from taxes may be available, call your county assessor for more information.

The Current Situation

This replacement levy is not a new tax. The individual tax rate depends on assessed home value. It will not exceed the amount of \$2.25 per \$1,000 of assessed property value.
