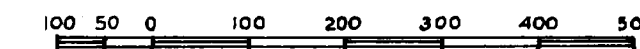


PLAT OF SCULLY'S FIRST ADDITION TO OLYMPIA WASHINGTON

DESCRIPTION

Beginning at a point marked by a concrete monument on the south side of Fourth Avenue West which point is North 88° 36' 32" West, a distance of 552.62 feet from the northwest corner of Block 27, Percival's Second Addition to Olympia; running thence South 1° 23' 28" West, 260 feet to a concrete monument; thence South 88° 36' 32" East 215.49 feet more or less to a concrete monument marking the west city limits of the City of Olympia; thence South 0° 27' 14" West along the said city limits 1345.57 feet to a concrete monument, thence; continuing South 0° 27' 14" West, 30.00 feet to a concrete monument, the west one sixteenth corner between Sections 15 and 22, Township 18 North, Range 2 West of the Willamette Meridian, thence South 89° 46' 36" West along the section line between said Sections 15 and 22, 564.27 feet; thence North 1° 23' 28" East, 30.01 feet to a concrete monument, thence continuing North 1° 23' 28" East 1621.28 feet to a concrete monument on the south line of Fourth Avenue West, thence South 88° 36' 32" East 326.06 feet more or less to the point of beginning; all of which is a part of the S.W. Percival Donation Claim No. 55, in Section 15, Township 18 North, Range 2 West of the Willamette Meridian in the County of Thurston and State of Washington.

DEDICATION

"Know all men by these presents that we, the undersigned, John A. Scully and Evelyn Scully, owners in fee simple of the land hereby platted, hereby declare this plat and dedicate to the use of the public forever, all streets, avenues, places and sewer easements or whatever public property there is shown on plat and the use thereof for any and all public purposes not inconsistent with the use thereof for public highway purposes; also, the right to make all necessary slopes for cuts or fills upon the lots, blocks, tracts, etc, shown on this plat in the reasonable original grading of all streets, avenues, places etc. shown hereon.
