Dear C Davis,

Your voter registration has been challenged by Andrew Saturn, based on the belief that you do not live at the address where you are registered to vote. The challenge process is established in the law RCW 29A.08.810 through RCW 29A.08.850. Voter registration records show your residential address as:

If this is incorrect, you may update your information by contacting our office at 360.786.5408, elections@co.thurston.wa.us, or at VoteWA.gov.

A hearing regarding this challenge has been scheduled for August 27, 2020 at 3:00 pm at the Thurston County Courthouse Bldg. 1 Rm 280. A voter registration challenge hearing is an administrative hearing, not a court proceeding, and will be open to the public. The County Auditor will preside over the hearing.

You may provide evidence that you live at the address where you are registered, update your residential address at **VoteWA.gov**, or prove that you meet one of the exceptions allowed in law. You do not lose your residency if you are:

- absent while in government service;
- attending school;
- confined in a public prison; or
- live at a non-traditional residential address. State law allows you to list the address of a shelter, park, motor home, marina, or other identifiable location that you consider to be your residence.

You may respond by appearing at the hearing in person, by Zoom, or by submitting written testimony. A sample declaration is attached. If you decide to respond in writing, it must be received by our office prior to the hearing. If you do not participate in the hearing, a decision will be made based on available information and you will be contacted regarding the outcome of the hearing.

Please see my attached voter registration challenge.

I have personally verified that the voter in question ("C Davis") does not reside at 1211 4th Ave E in Olympia. Per my visual inspection, the building is a 7,000 sq ft (approx) office building with 10 offices, 2 conference rooms, a kitchen, and 2 bathrooms. It has no residential units. Current occupants are entirely business-related and there is nobody acknowledging that they are collecting mail for "C Davis."



According to Thurston County Assessor (Steven Drew) records, the upstairs (Suite 200) is currently occupied by Olympia Family Chiropractic, and the bottom is owned/occupied by Fourth Street Associates LLC. Both are zoned for commercial and have no residential units on record. There is no way "C Davis" resides at this address.

There are no records for a "C Davis" residing in Thurston County. There are records for various parcels of land owned by "C Davis" in Grays Harbor, as well as various Seattle-based businesses ("Davis and Bechet Professional Saxophones," "Towering Inferno Orchestra," "Second Hand Fun," and "Northwest Musical Instrument Company") with the same email address (was2016@hotmail.com) used by "C Davis" in their PDC C1 registration found at https://apollo.pdc.wa.gov/public/registrations/registration?registration_id=18543. There are various musical instruments listed for sale on Craigslist by the "Davis and Bechet" company with a location in Lacey, WA: <https://seattle.craigslist.org/oly/msg/d/lacey-davis-and-bechet-eb-alto-trombone/7179086282.html>.

Interestingly, the other websites for these Seattle-based companies (listed at <https://www.blogger.com/profile/10831969835058454921> and <https://oly-wa.us/davisandbechet>) mention another

similar email address, "was2001@hotmail.com" which belongs to an individual named Michael Wasielewski. I don't know if this is the true identity of "C Davis" but it seems to make sense — "**was**" being short for "**Wasielewski**," which could be either a real name OR an associate of "C Davis." Both individuals are reported as being approximately the same age on various public records websites.

It is also worth noting, "C Davis" ran for office in 2018 for State Legislature, LD22 position #2, but was not registered to vote in Washington State until March 2018. "C Davis" filed for office a month earlier on February 22, 2018 according to PDC records at https://www.pdc.wa.gov/browse/campaign-explorer/candidate?filer_id=DAVIC%20%20503&election_year=2018. It is my belief that "C Davis" was also not qualified to run for office in 2018 if they were registered at the same commercial address. At this time, "C Davis" used the same Package Express in West Olympia as the address of their current (2020) campaign, and did not have any other officers registered on their committee.

On all documentation, "C Davis" lists their phone number as (360) 824-1613.

Hello

I'm writing about a candidate for Thurston County Commissioner, "C" Davis.

Recently, allegations have surfaced that "C" is an alias used to conceal the individual Celeste Davis Plover from their known history of sexual abuse of minors, stalking, and other predatory behavior.

While I am unaware of any criminal convictions for these activities, this individual may otherwise not be legally qualified to run for office in Thurston County.

Per public records, this person has falsely registered to vote under their alias "C Davis" and also is registered to vote at a commercial office building on 4th Ave E., which has no residential units.
