Dear Ms. Parshley,

Your voter registration has been challenged by Michael Snodgrass, based on the belief that you do not live at the address where you are registered to vote. The challenge process is established in the law RCW 29A.08.810 through RCW 29A.08.850.

Voter registration records show your residential address as: 1014 4<sup>th</sup> Ave E Olympia WA 98506

If this is incorrect, you may update your information by contacting our office at (360) 786-5408.

The County Canvassing Board, consisting of the County Auditor, County Prosecuting Attorney, and the Chair of the Board of County Commissioners, will preside over a voter registration challenge. The hearing is an administrative hearing, not a court proceeding, and will be open to the public.

The Board is scheduled to meet on Monday, October 2 at 3:00 p.m. to discuss the hearing process. While the public may attend, the Board will not hear from you or the challenger at this meeting. The discovery hearing regarding this challenge will be Wednesday, October 4 at 10:00 a.m. and the Board may hear from you and the challenger. Final deliberation/decision will be Monday, October 9 at 9:00 a.m. All three meetings will be at the Thurston County Auditor's Office, 2000 Lakeridge Drive SW, Building 1 Room 118, Olympia, WA 98502.

You may provide evidence that you live at the address where you are registered, update your residential address at www.myvote.wa.gov, or prove that you meet one of the exceptions allowed in law. You do not lose your residency if you are:

- absent while in government service; •
- attending school; •
- confined in a public prison; or •

You may respond by appearing at the discovery hearing in person, or by submitting written testimony. A sample declaration is attached. If you decide to respond in writing, it must be received by our office prior to the discovery hearing. If you do not participate in the discovery hearing, a decision will be made based on available information and you will be contacted regarding the outcome.

I have enclosed supporting documentation regarding my residency challenge to Lisa Parshley. Listed below is the information I am using to challenge her residency.

- 1. The Assessors site has listed the total number of living units at the 1014 4<sup>th</sup> Ave East Olympia WA address as zero. According to the assessor there are no living units at that site. Either she does not live here or there is a code violation.
- 2. July 22, 2016 her voter registration listed the Bayview address as her voting address. When she voted in August she either voted at that address which would mean she would not have had the year residency required to run for 2017 election cycle or she voted illegally as the law says the cutoff for address change is 29 days.
- 3. Her husband still lives at the Bayview address and is registered there.
- 4. She continues to pay property taxes at the Bayview address.
