**Referendum Measure No. 71**

The legislature passed Engrossed Second Substitute Senate Bill 5688 concerning rights and responsibilities of state-registered domestic partners and voters have filed a sufficient referendum petition on this bill. This bill would expand the rights, responsibilities, and obligations accorded state-registered same-sex and senior domestic partners to be equivalent to those of married spouses, except that a domestic partnership is not a marriage.

**Levy Lid Lift**

The Board of Commissioners of Thurston County Fire Protection District No. 7 adopted Resolution No. 09-03=R1 concerning a proposition to restore the District's regular property tax levy. The proposition would authorize the District to restore its 2009 regular property tax levy to \$1.00 per \$1,000 of assessed value for collection in 2010 to finance maintenance, operations, and capital facilities and would authorize setting a 1% limit factor for each of the five succeeding years and provide that the maximum allowable levy in 2015 shall be used to determine future increases as allowed by Chapter 84.55 RCW.
