- Members:** Ten members. Six members are selected by lot by the County Auditor from among registered voters, with two of these members from each of the three County Commissioner Districts. Four members are selected by the Board of County Commissioners to represent the following four sectors of the community: business, the legal profession, professional personnel management and organized labor.
- Meets:** Currently meets the third Monday of each month at 7:00 PM as needed. Meetings are held in Building 1, Room 152 of the Courthouse.

- Duties:** To set the salaries of the Thurston County Commissioners and to recommend to the Board of County Commissioners regarding the salaries of the elected Assessor, Auditor, Clerk, Coroner, Prosecuting Attorney, Sheriff, and Treasurer.
- Qualifications:** The six members selected by lot by the County Auditor must be registered voters of Thurston County at the time that they are selected for appointment to the Commission. The four members selected by the Board of County Commissioners must be residents of the Thurston County who have had experience in the field of personnel management. Members of the Commission may not include any officer, official, or employee of Thurston County or any of their immediate family members. For the purposes of this section, the phrase immediate family member means the parents, spouse, siblings, children, or dependent relative of an officer, official, or employee, regardless of whether the family member lives in the household of the officer, official, or employee.
- Appointment:** By majority vote of the Board of County Commissioners pursuant to the qualifications and terms referenced above.
- Removal:** No member shall be removed during his or her term of office unless for cause of incapacity, incompetence, neglect of duty, malfeasance in office or for a disqualifying change of residence. For the purposes of this section, neglect of duty shall include, but not be limited to, two unexcused absences within any calendar year. Any removal of a member shall be by majority vote of the Board of County Commissioners.
