> NOTICE OF ADOPTION BY THE THURSTON COUNTY BOARD OF COMISSIONERS: AMENDMENT OF THE THURSTON COUNTY COMPREHENSIVE PLAN, ZONING MAP, AND THURSTON COUNTY CODE NOTICE IS HEREBY GIVEN that the Thurston Board of County Commissioners adopted Resolution No. 15953 and Ordinance No. 15974, on December 15, 2020, effective immediately. Resolution No. 15953 amended the Thurston County Comprehensive Plan by repealing the 1996 Rochester Subarea Plan and replacing with an updated Rochester Subarea Plan, by amending Policy E.5 of the Nisqually Subarea Plan to allow for asphalt recycling in the Nisqually Subarea with the requirement for covered storage of recycled asphalt, and by amending the mineral lands, forestry, parks and health elements of the Thurston County Comprehensive Plan which includes amendments to Chapters 1, 2, 3, 6, 9, 11, Appendix C and D, the Future Land Use Map (Map L-1), the Long Term Agriculture and Forestry Map (Map N-1), and the Designated Mineral Lands Map (previously M-43, renamed as N-2). Additionally, seven parcels across unincorporated Thurston County totaling  $\pm 173$ acres are removed from the Long-Term Forestry designation, with the land use and associated zoning changed from Long-Term Forestry to Rural Residential Resource, One Unit per Five Acres. Ordinance No. 15974 amended "The Official Zoning Map, Thurston County Washington" (Section 20.06.010 TCC) to be consistent with the amended future land use map. This ordinance also amended several sections of the Thurston County Code related to mineral lands, including Chapters 17.20, 20.03, 20.30B, 20.54, and 20.60. Additionally, Chapter 20.54 is amended to include a requirement for covered storage of recycled asphalt for operations that process recycled asphalt within the Nisqually Subarea.
