

ORDINANCE NO. H-6-2012

AN ORDINANCE amending the Sanitary Code for Thurston County, Article I, Appendix A, Article II, section 5.2(c), and extending the expiration of food establishment permits issued in accordance with Article II, section 5.2 from December 31, 2012 to January 31, 2013.

WHEREAS the Board of Health is authorized to establish fees pursuant to Ch. 70.05 RCW; and

WHEREAS the Environmental Health Division of the Public Health and Social Services provides a variety of services to Thurston County citizens regarding food service, reviewing land use proposals, permitting and evaluating on-site sewage systems and water supplies, appeal, waiver and hearing processes, water quality testing, solid waste, water recreational facilities, drug lab clean up reviews, schools surveys and other investigations; and

WHEREAS the Board of Health seeks to assure that the costs to provide Environmental Health services are largely born by the citizens who request them, but do not exceed the actual cost of providing the services; and

WHEREAS growing payroll, county-wide overhead, and administrative costs have increased the cost of providing these services so they exceed the fees currently charged, resulting in a program budget deficit; and

WHEREAS the Board of Health desires to provide a stable funding source for the services by adjusting the fees on an annual basis to keep up with inflation, as indicated by increases in the Consumer Price Index; and

WHEREAS the Board of Health desires to move the permit period for food establishment permits from beginning January 1 and ending December 31, to beginning February 1 and ending January 31, so as to better fit within the County's budget review process; and

WHEREAS, in order to transition to the February 1 to January 31 food establishment permit period, food establishment permits expiring December 31, 2012 should be extended to January 31, 2013;

NOW, THEREFORE, the Thurston County Board of Health hereby ordains as follows:

Section 1. Article I, Appendix A of the Sanitary Code for Thurston County is amended to read as set forth in Attachment A which is incorporated herein by reference.

Section 2. Article II, section 5.2(c) of the Sanitary Code for Thurston County is amended to read as follows:

A permit shall be issued by the health officer when the application and an inspection of the food establishment demonstrates compliance with the provisions of this Article. A permit shall be issued for each year beginning February 1, or part thereof, and shall expire on the date indicated on the permit. Permit fees shall be charged as specified in Article I.


Section 3. Food establishment permits issued in accordance with Article II, section 5.2 that expire on December 31, 2012 are extended until January 31, 2013 at no additional cost.

Section 4. Severability. If any provision of this ordinance or its application to any person or circumstance is held to be invalid, the remainder of this ordinance or the application of the provision to other persons or circumstances shall not be affected.


Section 5. Effective Date. This ordinance shall take effect on January 1, 2013.



Appendix A - Environmental Health Fee Schedule

Effective: ~~July 10, 2012~~ January 1, 2013

All fees will be evaluated annually and may be adjusted by the Board of Health to cover the actual cost to provide the services.

**Fee Schedule Effective July 10, 2012 January 1, 2013**

The fees contained in this fee schedule shall be automatically adjusted each January 1 by the percentage increase, if any, in the July Consumer Price Index for the previous year. The maximum increase shall be 3.5%. "Consumer Price Index" for the purposes of this section shall mean the Urban Wage Earners and Clerical Workers Index for the Seattle – Tacoma- Bremerton area. For fees greater than \$70, adjustments based on the Consumer Price Index shall be rounded to the nearest \$5. An alternative calculation for automatically adjusting the charges may be adopted by further action of the Thurston County Board of Health

Fees include Thurston County Public Health and Social Services Department costs only. In cases where additional technical assistance is needed, costs for outside consulting services will be billed to the project in addition to the listed fee.
