

ORDINANCE NO. H-3-2010

AN ORDINANCE reducing the administrative fee for six-month food establishment permits set forth in Article I, Appendix A, Section II, A, 13 of the Sanitary Code for Thurston County.

WHEREAS, the Board of Health adopts the following findings:

1. The Thurston County Board of Health (Board) is authorized pursuant to RCW 70.05.060(7) to establish fees for permits and services, provided the fees do not exceed the actual cost of providing the services.
2. On October 6, 2009 the Board adopted Ordinance No. H-3-2009 which created an Administrative Fee for Six-Month Permit in the amount of \$45.00 for food establishment permits.
3. Recent analysis has shown that the cost of providing this service is, on average, \$15.
4. In order to avoid charging in excess of the actual administrative cost of providing this service, the fee should be reduced to \$15.00.
5. Emergency Ordinance No. H-2-2010 was adopted June 1, 2010 that reduces the fee for up to 45 days.
6. A regular ordinance must be adopted to incorporate this fee reduction into the Sanitary Code fee schedule and extend the reduction beyond the 45-day period.

NOW, THEREFORE, THE THURSTON COUNTY BOARD OF HEALTH HEREBY ORDAINS AS FOLLOWS:

Section 1. Article I, Appendix A, Section II, A, 13 of the Sanitary Code for Thurston County amended to read as follows:

Administrative Fee For Six-Month Permit . . . . . ~~\$45.00~~ \$15.00.

Section 2. This ordinance shall take effect immediately upon adoption.

Section 3. Upon adoption of this Ordinance, Ordinance No. H-2-2010 is rescinded.

Section 4. Severability. If any provision of this Ordinance or its application to any person or circumstance is held invalid, in whole or in part, for any reason, the remainder of this ordinance or the application of the provision to other persons or circumstances shall not be affected.



- [3] A preliminary design is used for individual lot analysis for the purpose of on-site sewage disposal review. It is used when specific detail is necessary to determine feasibility of lots within proposed subdivisions. It is not considered a formal permit application.
