### 5) <u>UPDATE ON THURSTON COUNTY SAFETY-NET PROVIDER</u> <u>COUNCIL</u>

Deborah Ahern, Personal Health Division Director, introduced Kristen West and Holly Greenwood both with the Thurston County Safety-Net Provider Council. Ms. West and Ms. Greenwood gave a presentation providing a review and update on the work of the Thurston County Safety-Net Provider Council. The Council consists of decision-level representatives from a comprehensive set of medical, dental, and mental health care safety-net providers in Thurston County. It works to identify gaps in the safety net and improve capacity collaboratively. Successes have been supporting SeaMar to recruit additional providers; development of shared referral form improving client flow among safety-net providers; and the expansion of SeaMar clinic to Community Youth Services (CYS) through a partnership between CYS, SeaMar and CHOICE. In addition, the Council has served as the body for critical discussions of maintaining and sustaining fragile safety-net programs and worked collaboratively to identify new administrative homes for programs that the Thurston County Public Health and Social Services Department could no longer support. These include Project Access, which links uninsured, low income adults with urgent medical needs with donated care; the Access to Baby and Child Dentists (ABCD), which links Medicaid insured families with dentists willing to provide dental care to infants and children; and WIC, the supplemental nutrition program for pregnant and breastfeeding women, infants and children .
