

MEDIC ONE STAFF REPORT – APRIL 2022

ALS Update:

- High Probability Unit (HPU) will remain unstaffed through April. It is anticipated that this unit will not be staffed again through the end of the public health emergency.
- Medic Unit Spec Advisory Committee is underway. As of March 18th, 2022, a local dealer has indicated it is backordered ~400 days from point of order for aid/ambulance/medic units. Anticipated completion of specs and order placement is late May/early June 2022 for delivery of the first 2 units in Q3 2023.
- Electronic Patient Care Record (EPCR) Committee will meet on April 20th at 09:30am. Documentation requirements will be discussed.
- Transportation Resource Utilization (TRU) Committee will meet April 14th at 13:00. This committee has a Zoom only option at this point.
- Paramedic testing was held on March 23rd-24th. There were 9 total candidates that tested with Medic One, and 6 of those candidates successfully made it onto the Medic One hiring list! In addition to the 4 that are currently on the list, this makes the current hiring list 10 total. The new process takes a number of individuals in order to coordinate an effective process, and we appreciate all of the patient actors, EMTs, and MSOs that it took to pull off.

BLS Update:

- The EMT Course for 2022-1 will be March 10th through June 4th. The Course will be a combination of online self-study, live virtual meetings and in-person practical skill and evaluations held at Station 95. The pre-requisite CPR Class will be offered as a combination online and in-person skills assessment on March 5th at Station 95.

- As of March 18th, 2022, 1,023 citizens have completed Hands Only CPR Training. Our Training Team is meeting regularly to work on increasing in-person opportunities as well as virtual reality type offerings. Thank you to all of our Instructors and Fire Agencies for teaching and hosting these classes.

IT Update:

- Medic One has started the purchasing of backlogged equipment orders. Supply-chain constraints continue to be an issue and are impacting delivery dates. Orders will be filled as equipment arrives at Medic One.
