## MEDIC ONE STAFF REPORT – MARCH 2022

## **ALS Update:**

- We are currently working on staffing the HPU Mondays and Fridays through the end of March. Extending the HPU past March will be reassessed by the TRU Committee. At this point in time, the expectation is that the HPU will be <u>unstaffed</u> after the 31<sup>st</sup> of March.
- EPCR Committee will meet on April 20<sup>th</sup> at 09:30am. We are currently discussing the PCR/NO PCR MPD Policy, and are attempting to close gaps in DOA, MVC, and Lift Assist dispositions that do not have PCRs.
- TRU Committee will meet March 10<sup>th</sup> at 13:00. This committee has a Zoom only option at this point. We will revisit migrating to an in-person option as of the anticipated change in the Governor's mandate on March 21<sup>st</sup>.
- Paramedic testing will be held on March 23<sup>rd</sup>-24<sup>th</sup>. Postings are now active on Medic One's website, agency websites, and Public Safety Testing's portal.

# **BLS Update:**

- The EMT Course for 2022-1 will be March 10<sup>th</sup> through June 4<sup>th</sup>. The Course will be a combination of online self-study, live virtual meetings and in-person practical skill and evaluations held at Station 95. The pre-requisite CPR Class will be offered as a combination online and in-person skills assessment on March 5<sup>th</sup> at Station 95.
- TAC will recommend approval for the job descriptions for the new Evaluator Process to Operations Committee in March.

- The job description for a full-time SEI has been posted.

- OTEP
  - All Online courses have been released for all BLS Providers and Instructors. Practical skills will be evaluated throughout the year.
  - BLS Certifications have been processed for all 2022 recertifying personnel.
  - Training will continue working with Lexipol (online training platform) in 2022 to prepare for County-wide implementation in 2023.
  - BLS Evaluator Workshops are scheduled for March 1<sup>st</sup>, 2<sup>nd</sup>, and 12<sup>th</sup> for 2022.

### **CPR Update:**

 As of February 15<sup>th</sup>, 2022, 495 citizens have completed Hands Only CPR Training. Our Training Team is meeting regularly to work on increasing in-person opportunities as well as virtual reality type offerings. Thank you to all of our Instructors and Fire Agencies for teaching and hosting these classes.
