What Are Opioids?

- Class of drugs which attach to opioid receptors in the brain to provide a variety of effects, including relief of pain
- Comes in both prescription and unregulated/illicit forms

Examples of opioids:

- Hydrocodone (Vicodin, Norco)
- Oxycodone (Percocet, OxyContin)
- Morphine (MS Contin)
- Hydromorphone (Dilaudid)
- Heroin
- Fentanyl

What Is Fentanyl?

- A synthetic opioid
 - 50-100 times stronger than morphine
- Pharmaceutical fentanyl was developed to manage pain in cancer patients
- Most fentanyl we see today is made in clandestine labs, not regulated pharmaceutically
- Can be used on its own, or mixed in with other substances (sometimes unknowingly)

Opioid Overdoses



- *Naloxone (Narcan®) can* be used to respond to an in-progress opioid overdose
- Fentanyl poses an increased risk for overdose
 - Much stronger than other opioids
 - May be used unknowingly, especially if mixed in with another substance

Fentanyl Specific Concerns


- Cannot cause an overdose just by touching the substance
 - Not absorbed well through the skin
- May require additional doses of naloxone to intervene during an overdose
 - This may be more doses than an individual has available
- Lethal in very small amounts
 - Can be hard to detect when mixed in with other substances

Opioid Response Task Force Strategies

- Increase information to partners and the community on fentanyl and the associated increased risks of overdose.
- Expand access to naloxone through services and systems that have direct contact with individuals at risk for overdose.
- Improve understanding of opioid overdose prevention, recognition, response, and naloxone use among partners and the community.
- Expand available education to local pharmacies on naloxone access, Washington's statewide standing order, and insurance coverage for naloxone.
- Increase available education on stimulant overdose/overamping.
