Welcome / Review Minutes / Review Agenda	Katie Strozyk welcomed everyone to the meeting, as Jon Tunheim was unable to attend. The November minutes and the March agenda were approved without updates. Introductions were saved for membership updates at the end of the meeting.
Overview and Successes of Olympia Bupe Clinic Justice Outreach	Garrett Leonard and Krystal Pierce shared information regarding the Justice Advocate Care Crew at Capital Recovery Center (see slides <a href="https://doi.org/10.1007/journal.org/">here</a> for more information).
Program	This program primarily connects with individuals while they are incarcerated or directly after they have been released. The goal is to assist individuals in stabilizing in the community post-release and decrease recidivism. Potential participants are about to view a 30-minute video while in jail which covers what buprenorphine is, how it assists in treating opioid use disorder, and the benefits of the treatment model. If someone is interested in services, they are connected to a Justice Advocate Care Crew member who does an intake to screen whether they qualify for the program (main criteria is having an opioid use disorder) and evaluate what other potential services/resources the individual may want to access.
	The Thurston County Jail's process of prescribing buprenorphine was described, for both individuals who enter with an active prescription and for those who do not have an active prescription but wish to initiate treatment prior to release from jail. If an individual is booked into jail with an active prescription for buprenorphine and has their script on them, then they can continue the medication immediately while in jail. If they are not already on buprenorphine when booked, they can request to initiate treatment shortly before their release date, with coordination between the Jail and Capital Recovery Center to ensure continuity of care post-release. The Jail also offers a buprenorphine taper for individuals who are actively in opioid withdrawal once booked for individuals who want to mitigate withdrawal symptoms.
	The Justice Advocate Care Crew program has recently expanded, because of the Olympia Community Court obtaining new grant funding. Through this expansion they can serve Community Court participants to assist them in accessing treatment and staying engaged in treatment. This partnership has also allowed for Capital Recovery Center to offer harm reduction and overdose response trainings within the community.

- Distributed safe medication disposal location cards to over 50 sites, including pharmacies & medical providers
- Developing a social media campaign focused on substance use protective factors (encouraging communication & positive relationships)
- Collaborating with the MedProject to place new medication disposal dropboxes

  - T1(a) Survey of local providers on topics of interest for the Medications for Opioid Use Disorder (MOUD) Provider meeting
- Upcoming community panel on services which build relationships with justice involved individuals & connect to treatment

- Coordinating education sessions regarding justice outreach, in-jail MOUD services, & continuum of care resources

### Overdose

- Completed one SMART Objective
  - O2(b) Provide education and naloxone kits to 10 businesses or organizations for use in the event of an overdose
- Developing an overdose education & response video in partnership with Thurston Community Media
- Working on creating a fentanyl specific resource on increased overdose risk & naloxone response

## Pregnant & Parenting

- Actively distributing pregnancy resource cards within the community
  - o Paired with pregnancy tests
- South Sound Breastfeeding Network working on fall conference regarding substance use & breast/chestfeeding
- Collaborating with State Opioid Response efforts to create a pregnant & parenting service provider list

Equity and Legal System Work Groups are still in the process of developing their SMART Objectives, as they are new work groups that are still in the beginning stages. The Task Force will revisit SMART Objective progress in the fall.
