


Passport Services

The Thurston County Auditor's Office is the only passport application acceptance facility in the county open full time. Passport services are available Monday through Friday, 8:30 a.m. to 4:00 p.m.

In addition to taking applications for new passports, our staff can also take photos. The State Department has strict requirements about photos that can be submitted for renewals or new applications. Our staff can make sure your photos meet those requirements.

After May 2023, passengers on domestic flights will be required to have a passport or enhanced driver license.

Drive-Thru Voter Services

When Thurston County closed its doors to the public during the COVID-19 pandemic, the Auditor's Office needed a new plan to conduct the Presidential Election. Ensuring access to voter services during a public health emergency took creative thinking, planning, and coordination.

The Auditor's Office worked with community partners to set up a drive-thru voting center at South Puget Sound Community College for the high turnout 2020 Presidential election. Thurston County Elections offered the following services on the South Puget Sound Community College campus:

- Voter registration
- Replacement ballots
- Voter registration updates Accessible voting services

The Auditor's Office continued drive-thru services at another location in 2021.



The Auditor's Office serves Thurston County by ensuring free, fair, safe, and secure elections, extraordinary recording, licensing, and passport services, financial integrity, accountability, and transparency.

Auditor's staff work every day to ensure free, fair, safe, and secure elections, extraordinary recording, licensing, and passport services, financial integrity, accountability, and transparency.

This report is an update on what we are doing and what we've accomplished over the last two years. In the wake of a historic pandemic, we were able to provide services to our community and keep staff working without a pause. The only service we temporarily suspended during the pandemic was passport services. We also:

- Secured stable election funding from the state;
- Successfully protected voters and staff from COVID-19 by standing up a drive-thru voting center during the 2020 Presidential Election year;
- Expanded eRecording to offer convenient online services during a pandemic and conserve public funds;
- Conducted outreach to homeowners impacted by racially restrictive covenants;
- Successfully piloted a countywide expansion of multi-factor authentication that protected cyber resources;
- Guided the massive flow of federal and other COVID-19 funds through county government;
- Continued providing excellent financial oversight by winning our 14th straight Certificate of Achievement for Excellence in Financial Reporting for our Annual Comprehensive Financial Report; and
- Ensured Thurston County's 6th straight clean audit from the State Auditor's Office.

Elections

The elections team accurately runs local, state and federal elections. We manage every part of the election process, from candidate filing to ballot design, processing, and security. We ensure that elections are free, fair, safe and secure.


Our services include:

We conduct fair and transparent elections with the highest integrity and accuracy. Our dedicated and reliable staff registers voters, makes sure you receive your ballot and counts your vote. We give you accurate and timely election results and information about voting.

Ballots Returned by Drop Box vs. Returned by Mail

Drop boxes remain the most direct way to return your ballot, especially closer to election day. Thurston County has 29 drop boxes, one of the highest per capita in the state. Ballot postage became prepaid in 2018.

The recording team assists Thurston County residents with document recording services. Our document recording services include:


- Customer service for document recording


Our licensing services include:

- Vehicle licenses

- Marriage licenses
- Some business licenses (unincorporated Thurston County only)
- Pet licenses (unincorporated Thurston County only)

We also oversee eight businesses in Thurston County that provide vehicle and vessel licensing services as subagents. We have increased our monitoring and annual auditing of subagents to ensure compliance and that they continue to provide excellent service to the public.

Financial Services

We provide financial services and accounting guidance to county offices and departments.

Our services include:

We ensure county government has a strong financial foundation. We process payroll and vendor payments. We compile county financial information for the public, state, and federal agencies. We are a resource for offices and departments in the county. We employ compliance experts for state and federal grants.

In 2021, for the 6th straight year, Thurston County received a clean audit from the State Auditor's Office. A clean audit reflects a strong financial culture and rigorous controls. The Government Financial Officers Association awarded Financial Services with its 14th consecutive Certificate of Achievement for Excellence in Financial Reporting for our Annual Comprehensive Financial Report.
