

ORDINANCE NO. H - 4 - 2018

AN ORDINANCE amending the Sanitary Code for Thurston County, Article I, Appendix A.

WHEREAS the Board of Health is authorized to establish fees pursuant to Ch. 70.05 RCW; and

WHEREAS the Board of Health seeks to assure that the costs to provide Environmental Health services are largely born by the individuals who request them, but do not exceed the actual cost of providing the services; and

WHEREAS growing payroll, county-wide overhead, and administrative costs have increased the cost of providing these services so they exceed the fees currently charged, resulting in a program budget deficit; and

WHEREAS permit volume in Environmental Health programs has steadily increased since 2014, and additional fee revenue is needed to add staff to improve customer service quality, reduce permit backlog times for customers, and reduce staff overtime; and,

WHEREAS the Board of Health desires to provide a stable funding source for the services by adjusting the fees on an annual basis to keep up with inflation, as indicated by increases in the Consumer Price Index; and

WHEREAS the Board of Health deems it necessary to amend the Sanitary Code fee schedule to show available laboratory tests and have the associated fee reflect costs of materials needed to perform those tests; and,

WHEREAS the Board of Health has determined it is necessary to amend the Sanitary Code fee schedule to reflect the current process for reviewing expired on-site sewage permits and have fees charged be commensurate with the work needed to complete the review; and,

WHEREAS the Board of Health has also determined that review costs for city land use projects that will be served by sewer are less than for projects where septic systems are proposed, and that the Sanitary Code fee schedule should be amended to fairly reflect these costs.


NOW, THEREFORE, the Thurston County Board of Health hereby ordains as follows:

Section 1. Article I, Appendix A of the Sanitary Code for Thurston County is amended to read as set forth in Attachment A which is incorporated herein by reference.


Section 2. Effective Date. This ordinance shall take effect on January 1, 2019.

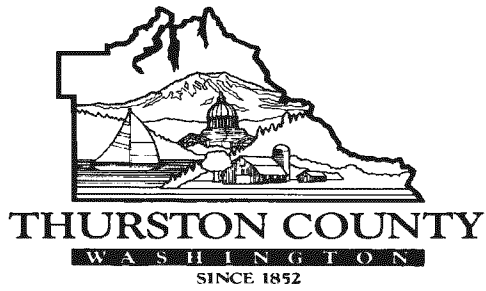

The fees contained in this fee schedule shall be automatically adjusted each January 1 by the percentage increase, if any, in the April Consumer Price Index for the previous year. The maximum increase shall be 3.5%. "Consumer Price Index" for the purposes of this section shall mean the Urban Wage Earners and Clerical Workers Index for the Seattle – Tacoma- Bellevue ~~Bremerton~~ area. For fees greater than \$70, adjustments based on the Consumer Price Index shall be rounded to the nearest \$5. An alternative calculation for automatically adjusting the charges may be adopted by further action of the Thurston County Board of Health

Fees include Thurston County Public Health and Social Services costs only. In cases where additional technical assistance is needed, costs for outside consulting services will be billed to the project in addition to the listed fee.
