Proclamation

Child Abuse Prevention Month

WHEREAS, children are the foundation for a prosperous and innovative society, and the foundation for a child's growth and development is established when every community takes responsibility for creating healthy environments where our children can thrive; and

WHEREAS, Thurston County supports the Strengthening Families Protective Factors that reduce abuse and neglect through promoting social connections, knowledge of parenting and child development, parental resilience, concrete supports in times of need, and the social and emotional competence of children; and

WHEREAS, a child's early experiences of being nurtured and bonded with consistent, caring adults affect all aspects of behavior and development, and is associated with better academic grades, healthier choices, improved physical and mental health, positive peer interactions, and an increased ability to cope with stress; and

WHEREAS, the American Rescue Plan authorized \$250 million for community-based child abuse prevention programs in Federal fiscal year 2021, there were still 3.9 million reports made to child protective services Nationwide; and

WHEREAS, 22% of Thurston County adults experienced physical child abuse before turning age 18, and by 8th grade 35% of county youth have experienced psychological abuse; and

WHEREAS, Thurston County recognizes it is the responsibility of every adult to protect children from all forms of adverse childhood experiences, including abuse and neglect, and recognizes the need for adults, organizations, schools, and communities to form protective barriers around children; and

WHEREAS, effective child abuse prevention programs are essential, and succeed because of community partnerships created among citizens, social service agencies, schools, businesses, law enforcement agencies, faith-based organizations, civic organizations, and other child-serving agencies; and

WHEREAS, Friday, April 7, 2023 is "Go Blue Day," a day when everyone is encouraged to wear blue to build awareness about child abuse and neglect prevention, and to inspire change by focusing on community activities and public policies that prioritize prevention.

NOW THEREFORE, BE IT RESOLVED, the Board of Thurston County Commissioners hereby proclaims April 2023, as Child Abuse Prevention Month in Thurston County, and urges all residents to actively participate in the care, well-being, and protection of our children.



RE: Board Member Vacancy – Proposed Solicitation Process

Thank you for your earlier email regarding the outreach for our board member vacancy. I understand the Board of County Commissioners (BOCC) would like to see a broad outreach for potential candidates before designating an appointee to the board vacancy. As you may recall, our vacancy came about in December 2022 when our board member, Lottie Mosebar, sold her property within the Black Lake Special District (BLSD). In doing so, Lottie became unqualified to vote in the BLSD and therefore could not continue as a board member (RCW 85.38.070(6)).

As I understand, the appointee will serve from the date of appointment by the BOCC until the next BLSD general election in February 2024, a period of nine to ten months. The elected board member will then serve out the remainder of Ms. Mosebar's term, which expires February 2028.

We have considered a couple of solicitation alternatives. Each alternative shares the following common items:

Candidates will be requested to mail or email a letter of interest to the BOCC via the Clerk of the Board. The letter should provide full name, address of property owned in the BLSD, a brief biography and reason(s) for wishing to serve on the BLSD board.

Alternative 1: Mail a soliciation letter to each of the 753 parcels within the BLSD. Request a return letter within 30 days if the property owner(s) wishes to be considered for the vacancy. It is estimated there are 1,300 qualified voters/potential candidates. Each parcel may have two qualified voters if the parcel is owned as community property (RCW 85.38.105(3)).

Discussion: This is the widest possible outreach and the most costly in terms of county and BLSD staff time and postage.

Alternative 2: Mail a soliciation letter to each of the attendees (19) at the October 2022 annual meeting. Post the soliciation letter on the BLSD web home page (<u>www.blacklakespecialdistrict.org</u>) and request a return letter or email within 30 days to be considered for the vacancy. Describe this alternative in detail in the BLSD meeting agendas and minutes.

Discussion: This is a more limited outreach. It does encompass BLSD voters who have participated in the annual meeting and who follow the BLSD proceedings by attending, via Zoom, the BLSD board meetings or reading the agendas and minutes for the meetings.

The BLSD board recommends Alternative 2. The alternative is less costly and can be accomplished more quickly. The outreach is biased toward BLSD voters who participate in BLSD events and/or follow BLSD activities. We think voters with these characteristics may be better board members.
