Hi Christina.

Ahead of tonight's meeting, I'd like to forward to you some suggested revision of text for the "purpose" section on the HCP. I appreciate the ESA referencing in the proposed revision, but it doesn't quite address all of the concerns I mentioned. I know I'm not a code writing professional or anything, but I looked around for some examples to help provide a clearer sense of how the ESA purpose and definitions can be more accurately stated (in a Plain Talk way), while also providing a better picture (e.g., for the Hearing Examiner) of the totality of what the HCP is supposed to accomplish and why from the Thurston County perspective.

Keeping in mind the concern expressed by planning commissioners regarding length, I aimed for brevity similar to the proposed revision presented. I hope it's useful. Regarding the reference to ecosystems and recovery, take a look at the purpose state and the definition of "conservation" provided in the ESA itself:

Section 2(b) "Purposes.—The purposes of this Act are to provide a means whereby the eco-systems upon which endangered species and threatened species depend may be conserved, to provide a program for the conservation of such endangered species and threatened species, and to take such steps as may be appropriate to achieve the purposes of the treaties and conventions set forth in subsection (a) of this section."

Section 3 paragraph 3: "The terms "conserve", "conserving", and "conservation" mean to use and the use of all methods and procedures which are necessary to bring any endangered species or threatened species to the point at which the measures provided pursuant to this Act are no longer necessary. Such methods and procedures include, but are not limited to, all activities associated with scientific resources management such as research, census, law enforcement, habitat acquisition and maintenance, propaga tion, live trapping, and transplantation, and, in the extraordinary case where popu lation pressures within a given ecosystem cannot be otherwise relieved, may include regulated taking."

17.40.015 Purpose

The purpose of this Chapter is to implement the Thurston County Habitat Conservation Plan (Thurston HCP) according to the Implementing Agreement with the US Fish and Wildlife Service, in order to provide a regulatory framework for promoting the protection and recovery of rare, threatened and endangered species and the ecosystems on which they depend, while improving and streamlining the permitting process for covered activities and planned development in Thurston County.

The United States Endangered Species Act (ESA) and its implementing regulations in Title 50 of the Code of Federal Regulations (CFR) Section 17, prohibits the "take" of any fish or wildlife species that is federally listed as threatened or endangered without prior approval pursuant to either Section 7 or Section 10 of the ESA.

The Thurston HCP enables the County to obtain federal permission to mitigate the incidental "take" of listed species that results from activities that are not otherwise prohibited. It provides a process for issuance of take authorizations for Covered Species, including those which are not currently listed but which may be listed in the future, without the imposition of additional mitigation requirements outside of the Habitat Conservation Plan process.

The Thurston HCP provides an efficient process for conserving species and protecting natural resources by creating larger scale, more ecologically viable and more efficiently manageable mitigation sites, as well as a framework for providing permits and authorizations for with lawful Take coverage under the ESA.
