
You will need:

- Black ink pen
- Clear tape (optional)
- Envelope (optional)

Your ballot packet will include:

- Your ballot
- Declaration and signature sheet
- Optional cover sheet
- Envelope cut-out sheet

- 1 Vote and prepare your ballot packet
- 1. Print your ballot packet.
- 2. Review your selections or mark your choices by hand.
- 3. Sign and date your Declaration and signature sheet.
- 4. Arrange your completed ballot packet in the order shown below:
 - a. Declaration and signature sheet
 - b. Optional cover sheet
 - c. All of your ballot pages



2 Return your ballot There are three ways to return your ballot.

Option 1: Email/fax option

You can return your ballot packet by email or fax no later than 8 p.m. (PDT) on Election Day, April 25, 2023.

To email your ballot:

- 1. Email your ballot packet as an attachment to **eballots@co.thurston.wa.us** You can take a clear and legible picture of your ballot packet pages with a digital camera or smart phone.
 - · Do not send a link.
 - Do not exceed a file size of 10MB.

To fax your ballot:

1. Fax your ballot packet to 360.705.3518

Option 2: Mail

Place your ballot into an envelope using the Envelope Cut-Out Sheet as instructed. The date you indicate on the voter declaration is considered the date of mailing and must be no later than Election Day, April 25, 2023. Your ballot must be received no later than the day before election certification.

Option 3: Ballot drop box

Place your ballot into an envelope using the Envelope Cut-Out Sheet as instructed. Ballot drop boxes open on April 5 and close promptly at 8 p.m. on Election Day, April 25, 2023. Visit **www.ThurstonWAVotes.gov** to find one of the **13** ballot drop boxes open for this election.

1 Read the declaration	 I do solemnly swear or affirm under penalty of perjury that I am: A United States citizen; A Washington state resident that meets the requirements for voting mandated by state law; At least 18 years old on election day, or 17 years old at the primary and 18 years old by the day the November general election; Voting only once in this election and not voting in any other United States jurisdiction; Not serving a sentence of total confinement under the jurisdiction of the Department of Corrections for a Washington felony conviction or currently incarcerated for a federal or out-of-state felony conviction; Not disqualified from voting due to a court order; and Aware it is illegal to forge a signature or cast another person's ballot and that attempting to vote when not qualified, attempting to vote more than once, or falsely signing this declaration is a felony punishable by a maximum imprisonment of five years, a maximum fine of \$10,000, or both.



If you are returning your ballot materials by mail use the envelope image below for pre-paid postage and first-class delivery.

Instructions

- 1. Cut out envelope image below along the dotted lines.
- Tape the image onto an envelope. Be careful not to cover the postmark area in the upper right corner of your envelope with tape.
- Fold the completed ballot packet (declaration and signature sheet, optional ballot cover sheet, and ballot) and place it into the envelope. ω.
- 4. Seal and mail the envelope.
