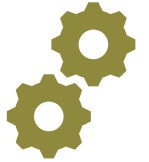

NUTS & BOLTS

- Administered by Thurston County Sheriff's Office Corrections Bureau
 - Subcontractor is Olympic Health & Recovery Services (new as of 2022)
- Provides substance use disorder treatment services using Moral Reconciliation Therapy (MRT) to Drug Court participants and Jail Inmates held in the Thurston County Correctional Facility.

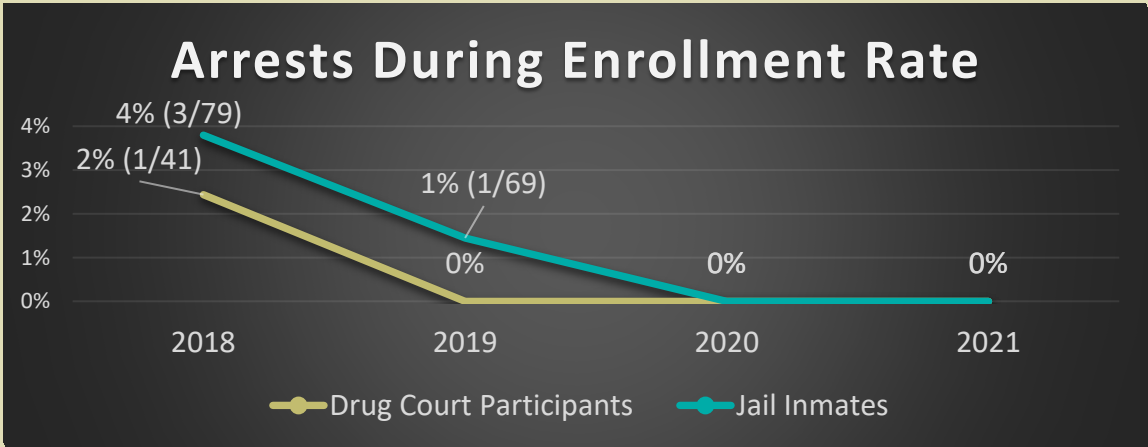
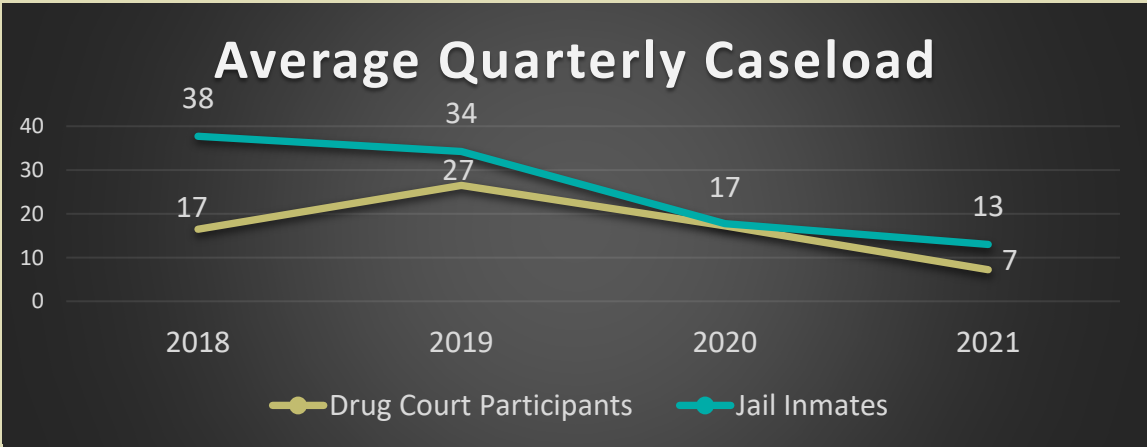
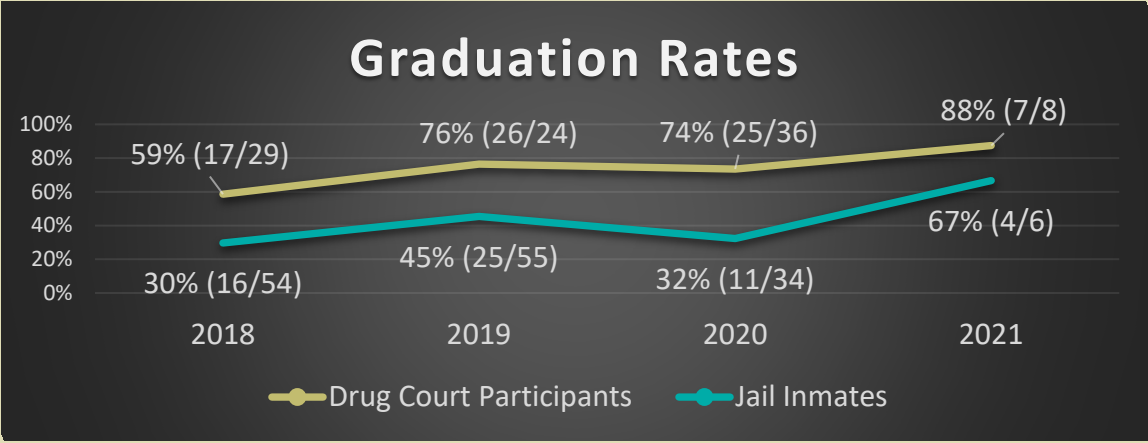
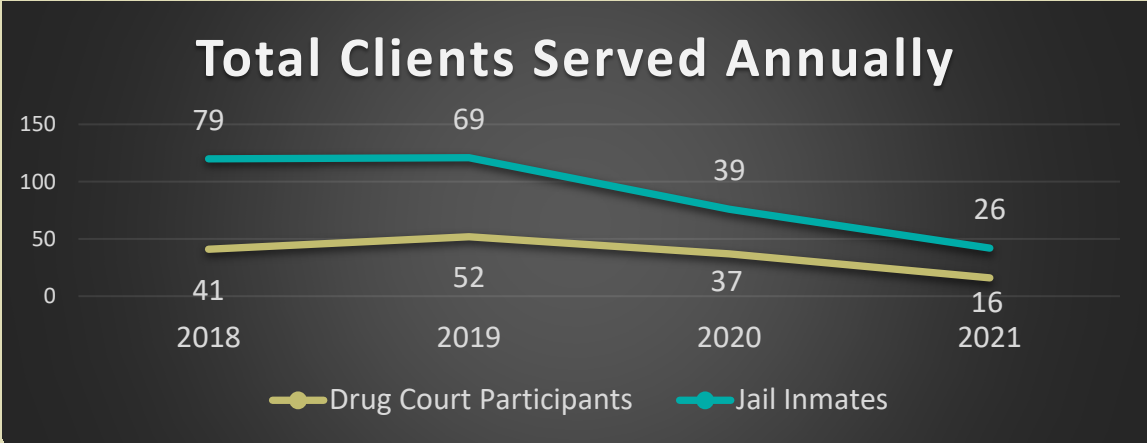

- We would like to get more referrals from the courts, especially females. We would also like to look at having a MHP Therapist that is dedicated to CDP Participants.



WIND IN YOUR SAILS

- New SUD treatment provider, OHRS.
- Continued partnership with Thurston County DUI/Drug Court Program.



ANCHORS & ROCKS

- The backlog in Court cases limits admissions because those being court ordered to participate do not have enough time left to complete the program.

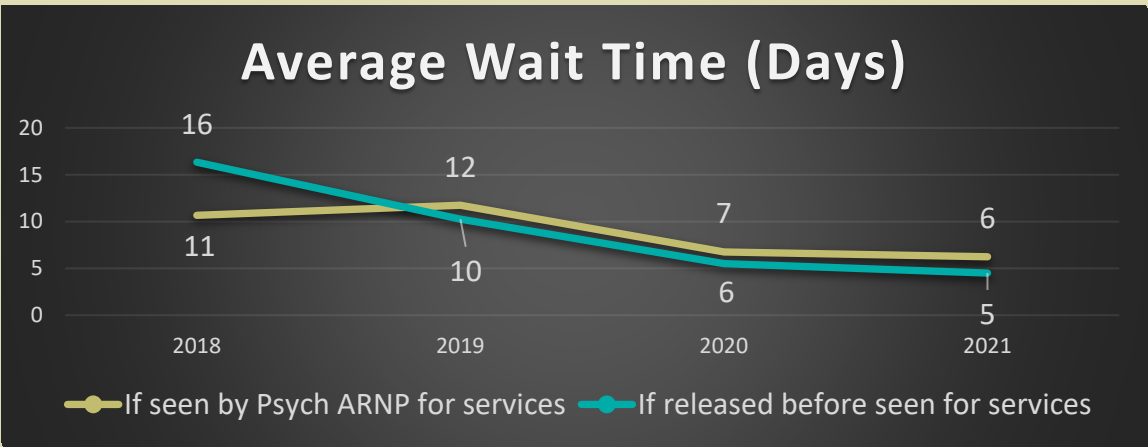
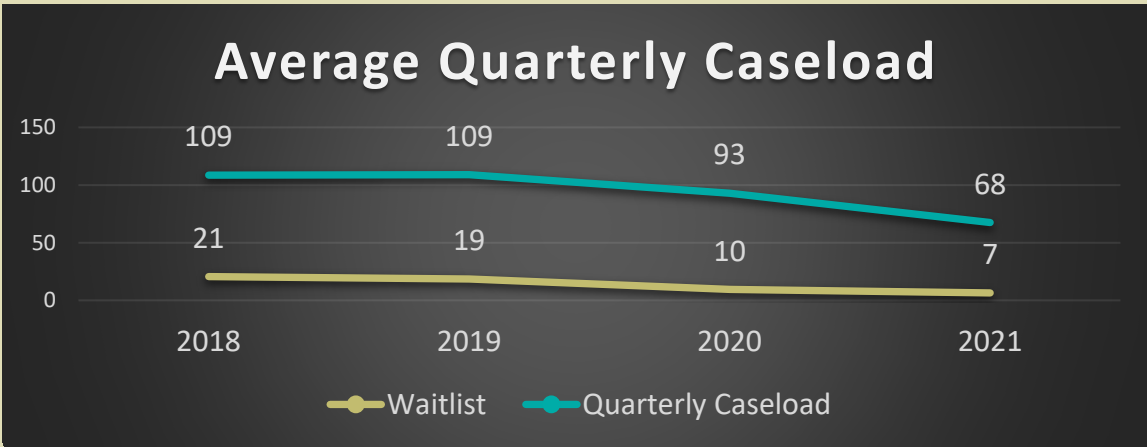
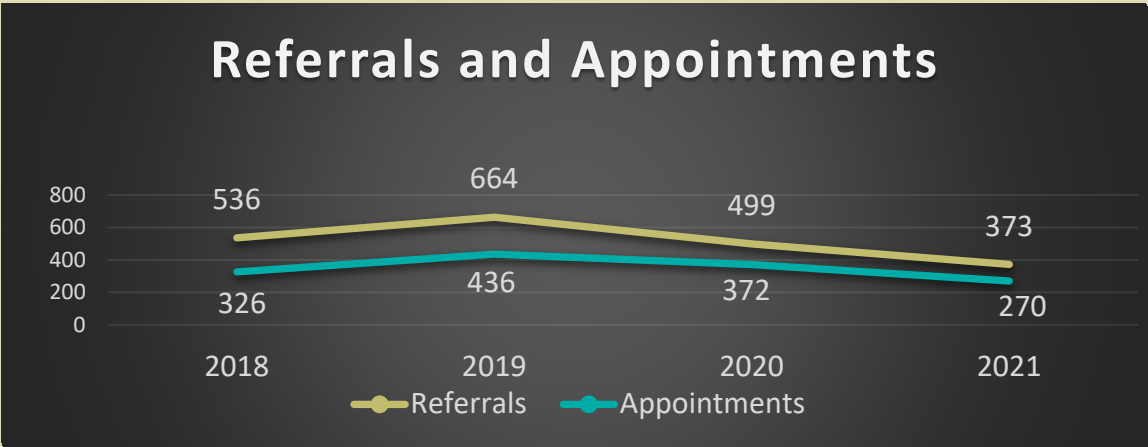
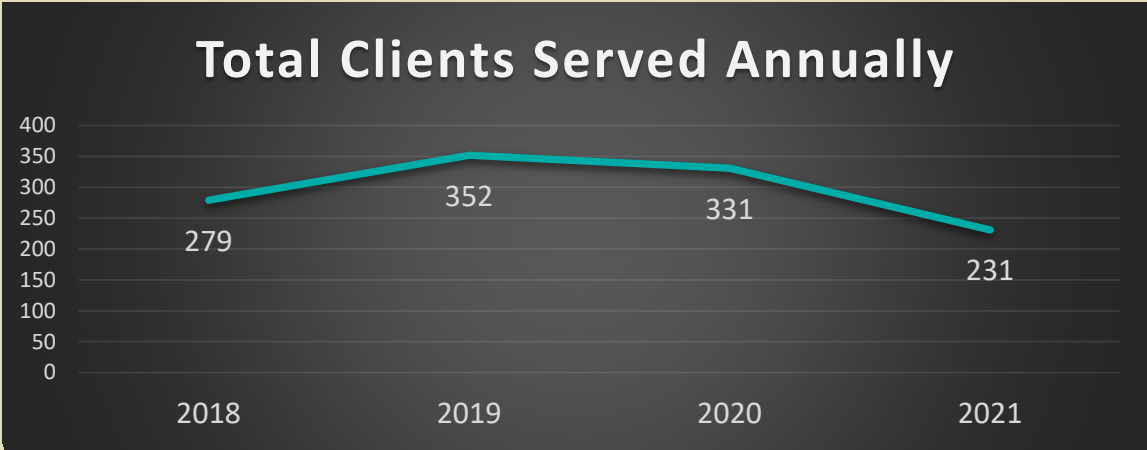
NUTS & BOLTS

- Administered by Thurston County Sheriff's Office Corrections Bureau.
 - Subcontractor is Healthcare Delivery Systems
- The following programs are part of this budget:
 - Psych ARNP Prescriber*: Prescribes, administers, and monitors psychiatric medications for individuals in the Thurston County Correctional Facility.
 - Re-Entry Assistance*: Focuses on transition planning and education for individuals in the Thurston County Correctional Facility with behavioral health disorders who will be released back into the community.
 - Transitions & Medication Management*: Ensures individuals in the Thurston County Correctional Facility with mental illness are connected to medication management to reduce symptoms that impair functioning and case management to support the transition from to work release or electronic home monitoring.
 - Pre-Trial Release*: Focuses on service planning (including connections to treatment and housing) to support the release of individuals with behavioral health disorders while charges are pending (when appropriate).

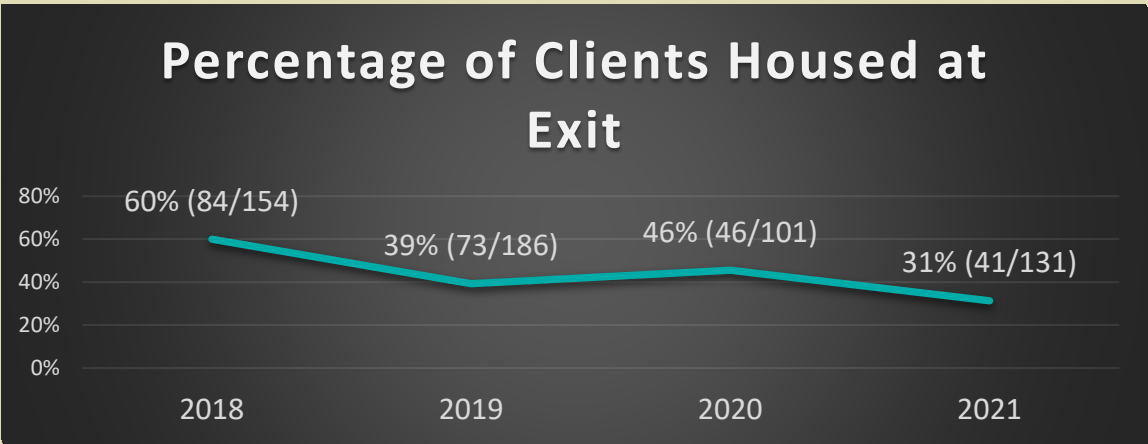
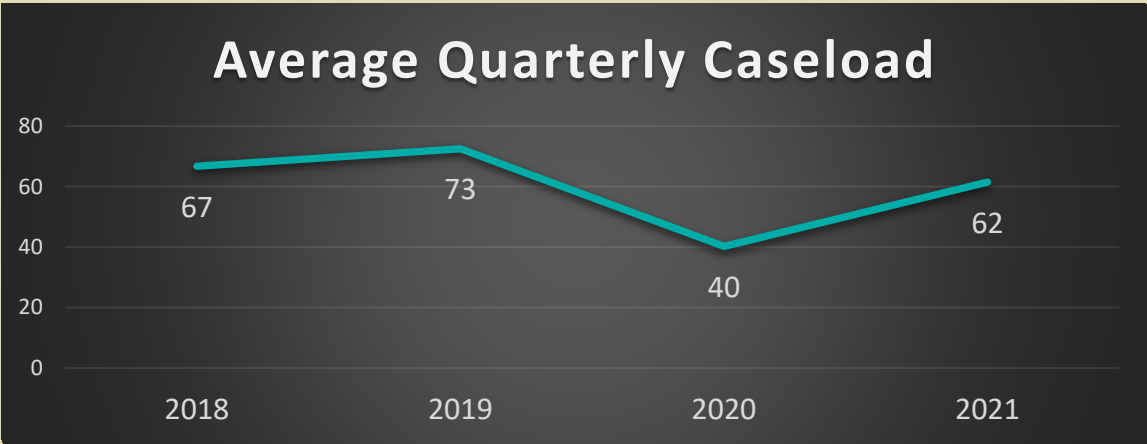
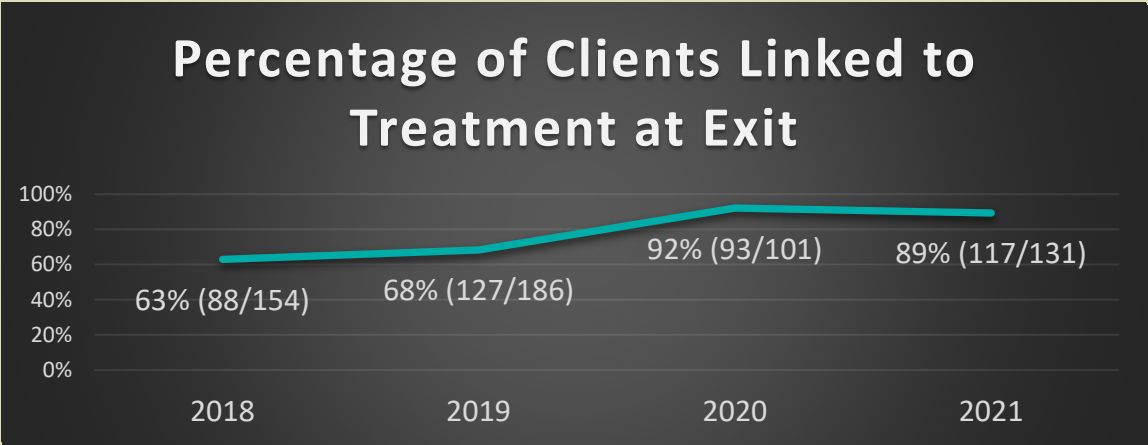
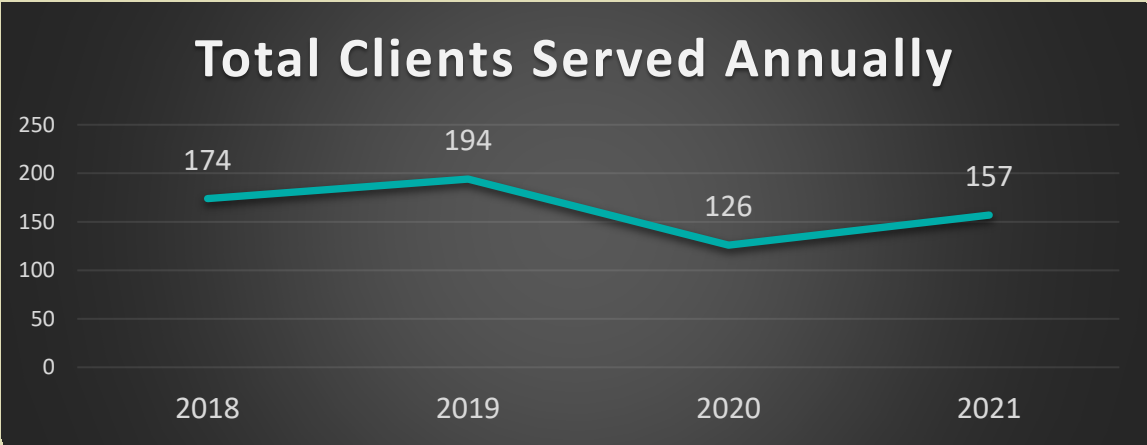


THURSTON COUNTY JAIL RE-ENTRY ASSISTANCE

INMATE MENTAL HEALTH SERVICES

Highlights



PARADISE FOUND

- Stronger coordination of wrap around services that would both benefit the individual releasing and the community.
- Our contracted Psych ARNP is conducting in-person appointments with individuals. Wait time for new referrals is about 6-7 days. TST funded 10.77 medication is going well.



WIND IN YOUR SAILS

- Living Skills classes assist individuals with learning skills they need for their transition back into the community.
- Re-Entry planning sessions allow the individuals to actively participate in putting together a positive plan of action in place for their success release back into the community.



ANCHORS & ROCKS

- Difficulty coordinating with outside agencies for services to assist individuals releasing to the community.
- Work Release not currently open/operating
- Wait time for those awaiting competency restoration is very long.

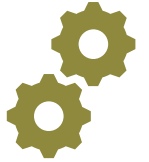

This training would be based on a Pre-Survey developed by Nicole. The goal is to have 4 to 5 training sessions utilizing trainers who have a background in behavioral health. WHAT ELSE?

- Would like to look at obtaining funding for one (1) night of lodging for those releasing that have been unable to find housing. This would allow a safe place for them until they are able to connect with the services that have been set up for them in the community. Those who are at a higher risk would work with a peer support to help assist them.

 - Subcontractor is Pacific Mountain Workforce Development Council
- Provides pre-employment training workshops and services to adults with behavioral health disorders in the Thurston County Jail with the goal that participants will become gainfully employed at exit.

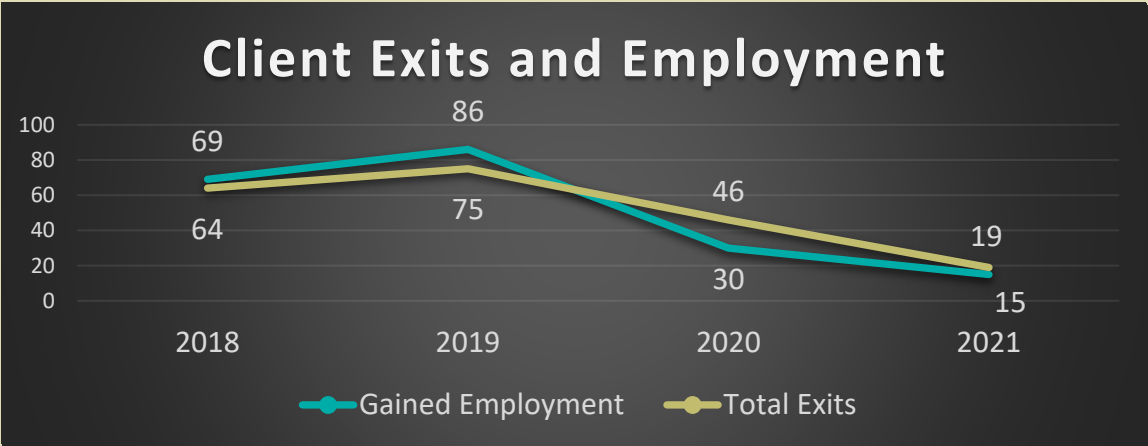
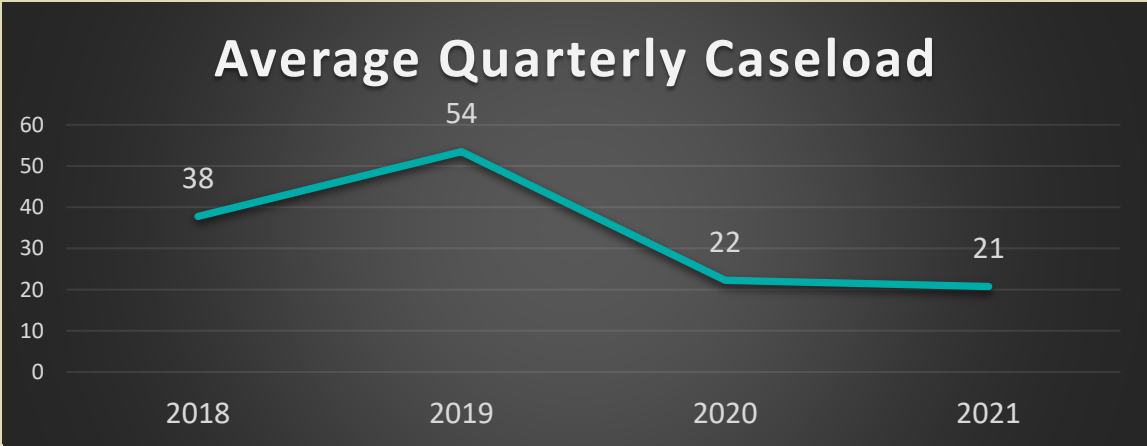
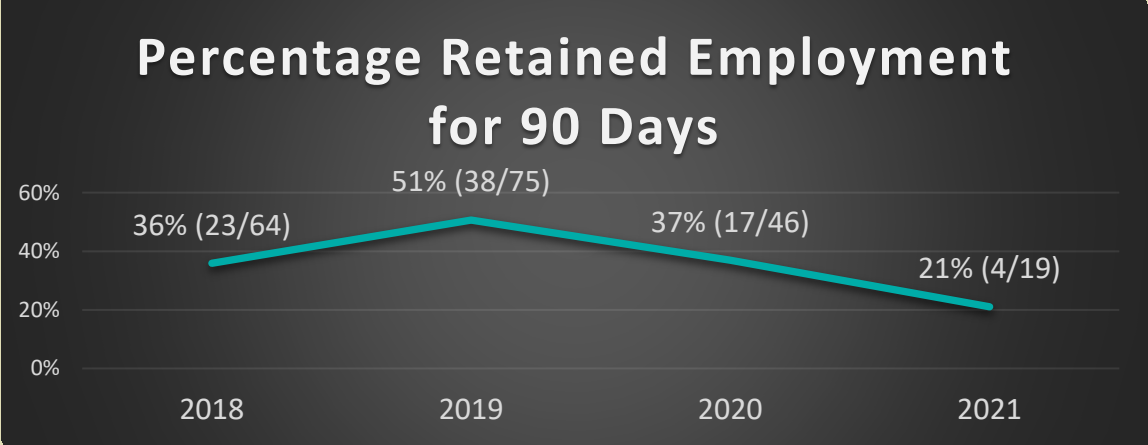
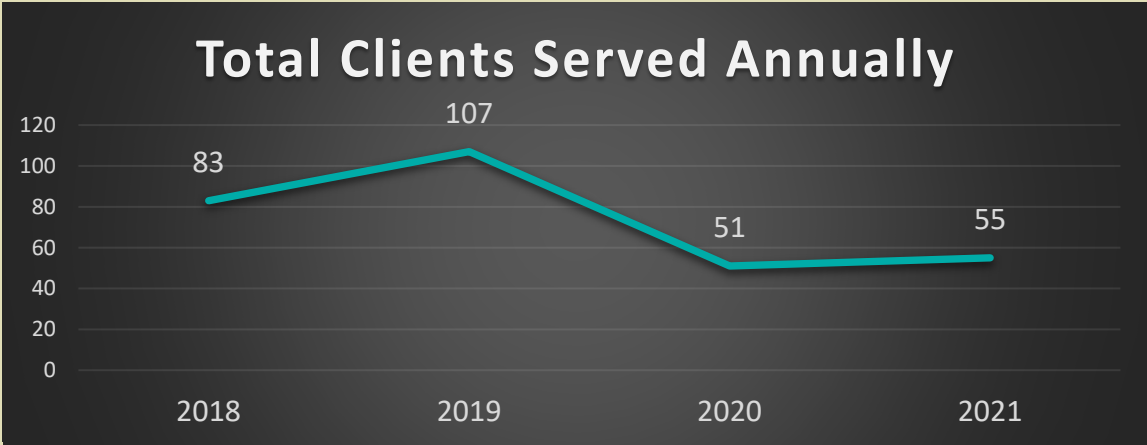

PARADISE FOUND

- Engagement with participants is very different in comparison to pre-pandemic engagement. This has initiated some out of the box thinking that lead to some innovative ways to serve participants.



WIND IN YOUR SAILS

- Ability to provide participants with mobile technology makes it easier to connect with them upon release.
- New programs and projects allows us to provide more resources to participants and to their family members affected by the incarcerated participant.



ANCHORS & ROCKS

- Not able to have face to face interaction to facilitate classes.
- Community resources have changed many of the ways they are operating, which have created additional barriers for those from out of state and those who need more intensive services.
- Department of Licensing still not acknowledging ID letters from TCCF.

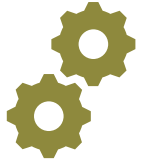

- Strong support from TCSO Leadership for programing in the jail.
- Strong partnerships with Olympic Health and Recovery Services, Healthcare Delivery Systems, PacMtn, NW Resources and Thurston County DUI/Drug Court.



ANCHORS & ROCKS

- Virtual programming, although better than no programming at all, can be challenging and does not always have the same dynamic or impact to participants that in-person classes do.
- Many program providers wish to be back to in-person programs and as soon as we can safely do resume in-person programming we will.

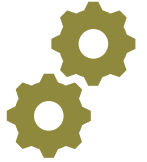

- Provides clinical mental health and crisis services to adults in the Thurston County Correctional Facility. Previously called "Mentally Ill Offender Program".

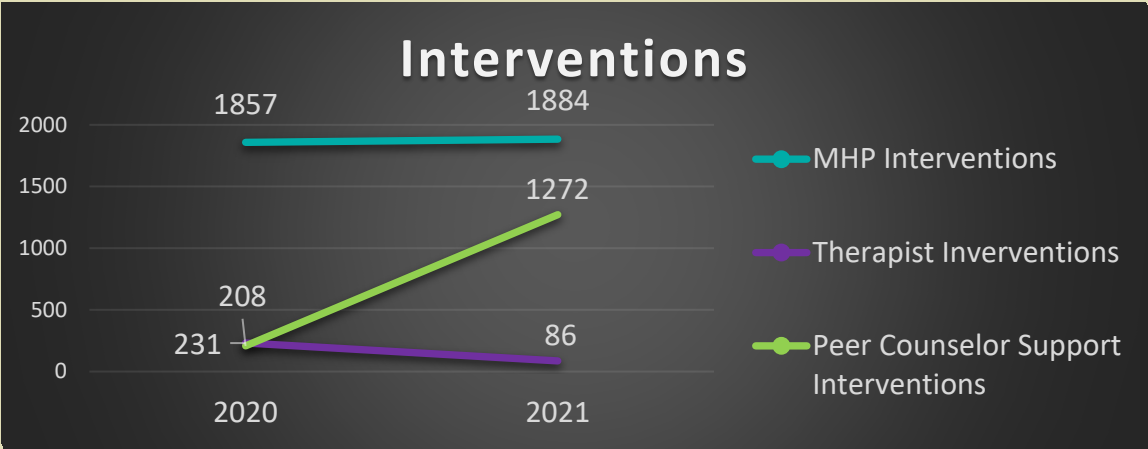
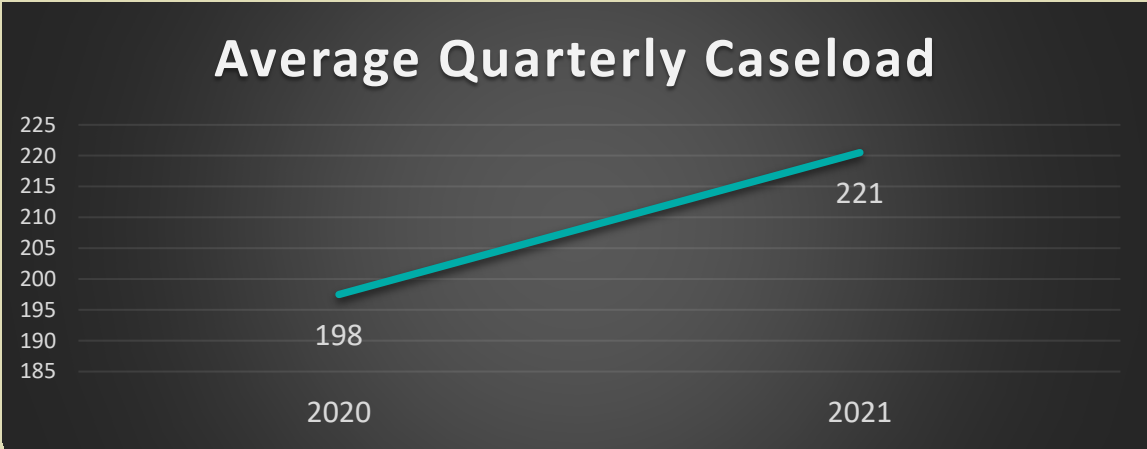
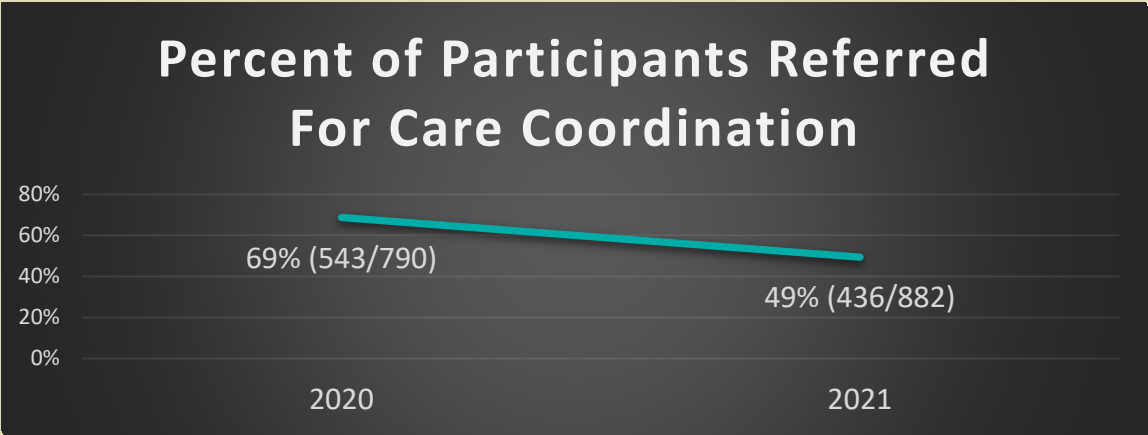
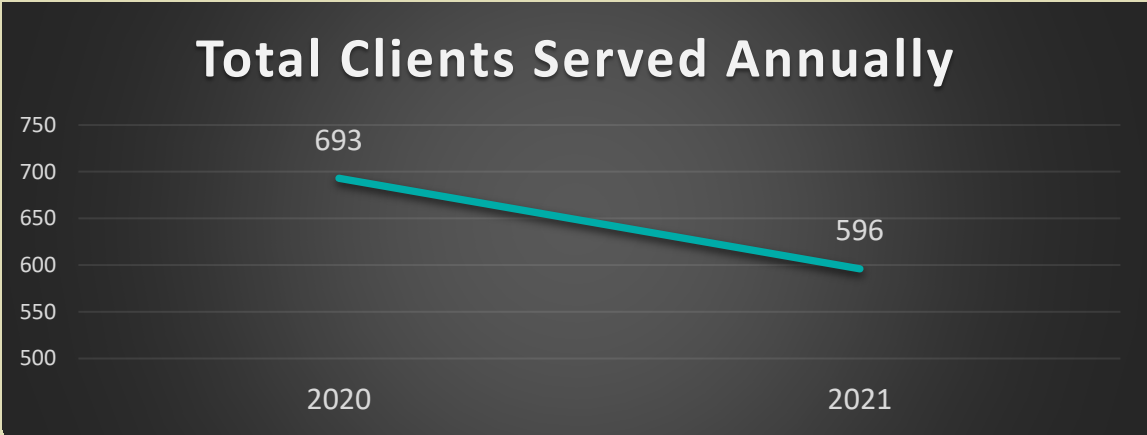
