Background

Registered voter CYNTHIA L SHUMAN, 9/14/1953, is registered with a residence address of 10900 Littlerock Rd SW in Olympia, WA and a status of Active. There is a mailing address on file for this voter in the Voter Registration Database (VRDB) of 18729 95th Ave Ct E in Puyallup, WA.

Previous History

The Washington Voter Research Project originally canvassed this address on November 30, 2021. At the time, resident Jared Warren indicated that SHUMAN has not resided there since December 2019 or earlier.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. SHUMAN was on this list. However, SHUMAN's voter registration is unchanged. This voter, or someone using this voter's identity, continued to vote using this residence address and voted in the November 2022 election.

Affidavit

On April 27, 2023 affiant Jared Warren, at 10900 Littlerock Rd SW in Olympia, WA, signed an affidavit declaring that registered voter CYNTHIA L SHUMAN does not reside at that address.

Letter

On May 4, 2023 I mailed a letter via USPS Certified Mail to both addresses on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

Envelopes

On May 17, 2023 the letter to the residence address in the VRDB was returned to me as undeliverable. On May 27, 2023 the letter to the mailing address in the VRDB was returned to me as unclaimed.

The data also shows that SHUMAN last voted on November 8, 2022. There are no registered voters named CYNTHIA SCHMITT with a DOB of 9/14/1953.

As of 6/15/23, the Federal Bureau of Prisons Inmate Locator shows a previous incarceration for a Cynthia Shuman, but the age is inconsistent with SHUMAN's birthdate and this inmate was released in 1998. There is no incarceration listed for Cynthia Schmitt.

Conclusion

An affidavit was obtained attesting that CYNTHIA L SHUMAN does not currently reside at 10900 Littlerock Rd SW in Olympia, WA. The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letters to the voter, to both the residence and mailing addresses listed in the VRDB were returned undeliverable/unclaimed.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810.
