Background

Registered voter DEVON EUGENE LYNCH, 4/15/1998, is registered with a residence address of 5815 Lacey Blvd SE in Lacey, WA and a status of Inactive. There is no separate mailing address on file for this voter in the Voter Registration Database (VRDB).

Previous History

The Washington Voter Research Project originally canvassed this address on September 28, 2021. At the time, the canvasser noted that this location is the Lacey Post Office, a nonresidential address.

On February 7, 2022 I emailed to the Thurston County Auditor's Office a list of 1,927 voters that no longer lived at their registered residence address. LYNCH was on this list. However, LYNCH's voter registration is unchanged.

Affidavit

On April 26, 2023 affiant Aaron Robinson, postal manager at 5815 Lacey Blvd SE, signed an affidavit declaring that registered voter DEVON E LYNCH does not reside at that address.

Letter

On May 22, 2023 I mailed a letter via USPS First Class Mail with Return Service Requested to the address on file in the VRDB, notifying the voter that their residence address listed in the voter database is incorrect. The letter encouraged the voter to update their voter registration, provided several different ways the voter could do so, and included an official Washington State Voter Registration Form.

On or about June 4, 2023 the letter to the residence address in the VRDB was returned to me as "Insufficient Address – Unable to Forward".

The data indicates that the voter does not own property in Thurston County, is not registered to vote from another address in Washington state, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter to the residence address listed in the VRDB was returned marked "Insufficient Address – Unable to Forward". A potential new address of 801 Israel Rd SW, Apt H101 in Tumwater, WA was found in online databases.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810.






